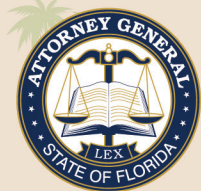





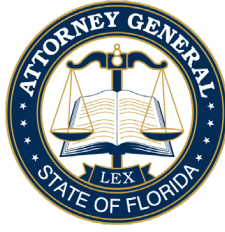

## Holiday Season Shopping Tips

---

*With so many consumer purchases taking place during the holiday season, it is a good time to be particularly mindful of potential scams, security issues and added costs that may impact your online purchases. Below are tips to keep your money safe while making the most of holiday shopping.*

- ❖ When shopping online, it is often wise to pay with a credit card instead of a debit card, if possible. Both payment methods allow you to dispute a charge if the merchandise never arrives or is different from what was ordered; however, with a debit card, the purchase is already deducted from your bank account and it may take days or weeks for your bank to reverse the charge.
- ❖ When ordering online, ensure that the web browser has a secure connection before inputting or submitting payment information. In the address bar, a padlock should appear to signify that your session is secure.
- ❖ Keep your receipts and be sure you understand retailers' return policies and periods so you can return any unwanted items for a full refund.
- ❖ Some retailers offer layaway plans or other payment options to allow shoppers to pay for items in installments or at a later date. Before agreeing to such a plan, be sure to ask whether the retailer charges a fee for its program and whether payments and any fees are refundable if the purchase is canceled or returned.
- ❖ When purchasing gift cards, check whether there is an additional activation fee, and provide the activation receipt to the recipient. Additionally, consider the retailer's financial situation before buying a gift card. If the retailer closes or declares bankruptcy, the recipient may not be able to enjoy the card's value.
- ❖ If shopping with a new retailer, check with the Better Business Bureau at [BBB.org](https://www.bbb.org) to determine whether other customers have filed complaints against them.

## Tips for Charitable Giving

---

*While the holiday season is a time for kind and generous deeds, scam artists may seek to take advantage of this spirit of giving. Below are tips to help ensure your charitable dollars do the most good this season.*

- ❖ Research before donating to a charity. Know if a charity is registered to solicit in Florida, be aware of how much your donation will actually go towards charitable programs as opposed to administrative expenses and check others' feedback on the charity. Websites like [FDACS.gov/ConsumerServices](https://www.fdacs.gov/ConsumerServices), [Guidestar.org](https://www.guidestar.org) and [CharityNavigator.org](https://www.charitynavigator.org) allow potential donors to review charities to help make sure the donation doesn't go to a scam organization.
- ❖ Do not give your credit card number or bank account information to someone who has called or emailed you unsolicited. If you are interested in donating to a charity that has contacted you, ask them to mail you information about the charity and a pledge form. Legitimate charities should have no problem with this request.
- ❖ Watch out for similar sounding charities. It is not unusual for sham charities to choose names that sound like the names of legitimate, well-known charities.
- ❖ Know the difference between tax exempt and tax deductible. An organization that is tax exempt does not have to pay taxes, but this does not necessarily mean that a contribution you have made to it is tax deductible. To check whether an organization is eligible to receive tax-deductible contributions, visit [Apps.IRS.gov/App/Eos/](https://apps.irs.gov/app/eos/).



## Product Recalls

---

*During this season of joy and giving, it is important to remain vigilant about the safety of the products brought into your home. What follows is a compilation of 2022-2023 U.S. product recalls in an easy-to-use guide that provides important information on items you may give or receive this holiday season.*

This guide reproduces U.S. Consumer Product Safety Commission information and details about recalled toys, baby items, sporting and recreational goods, furniture, and household products that are either designed for, or pose a particular risk to, children and teenagers. These items were among the more than 200 products recalled by the U.S. Consumer Product Safety Commission between October 1, 2022, and October 15, 2023. For more information regarding these products or for a comprehensive list of all product recalls, please visit [CPSC.gov](https://www.cpsc.gov).

Dangerous and defective products are the subject of recalls every year. When a product is recalled, the law requires manufacturers and retailers to remove the products from their shelves. However, products subject to recall sometimes slip by undetected and remain in stores; others may have been purchased before a recall was ever issued. Additionally, many products often continue to be offered for sale through online reseller websites well after a recall has been announced. Therefore, it is always important to do your research to make sure that the products you are buying or bringing into your home are safe and free of defect.

Taking a few minutes now to peruse this collection of recalled items will ensure a safer and more enjoyable holiday season for you and yours.



# Toys



## *HABA USA Discovery Cubes Animal Hide and Seek Activity Toys*

**Hazard:** The seam on the activity toy's house can open, allowing a young child access to the toy's filling, posing choking and ingestion hazards if placed in the mouth.

**Remedy:** Consumers should immediately take the recalled toy away from the child, cut the toy in half with a pair of scissors, take a photo of it, and discard it in the household trash. Contact HABA to receive a \$30 refund or gift card. Email a photo documenting that the toy has been destroyed, along with your contact information to [recall@habausa.com](mailto:recall@habausa.com) to receive the refund. HABA is contacting all known purchasers.



## *Professor Puzzle Wooden Rainbow Stacker*

**Hazard:** The toy's information sticker can become exposed and detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately take the recalled stacking toys away from children, stop using them and contact Professor Puzzle for instructions on how to remove and dispose of the sticker or to receive a refund of \$20 of the 11-inch toy and \$15 for the 7-inch toy. Consumers will be asked to return the product in a prepaid mailer. Consumers can also return the product to the retail store for a full refund of the purchase price.



## *BS Interactive Recalls Stashables Children's Ramp Sets*

**Hazard:** Surface paint on the miniature skateboard and scooter toys in the ramp sets contain levels of lead that exceed the federal lead paint ban, posing a risk of lead poisoning. The miniature scooter toy also fails to comply with the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health effects.

**Remedy:** Consumers should immediately take the recalled miniature scooters and skateboards away from children and contact BS Interactive to receive free replacement scooters and skateboards, including free shipping. Consumers will be asked to submit a photo of the disposed recalled scooters and skateboards. BS Interactive is contacting all known purchasers directly.



## *Tangame Busy Toy Houses*

**Hazard:** The yellow-painted metal zipper contains levels of lead that exceed the federal lead paint ban, posing a lead poisoning hazard; the orange plastic phone cord contains levels of lead that exceed the federal lead content ban; and the horn's blue plastic bulb contains a regulated phthalate that exceed the prohibition of specific phthalates. Phthalates and lead are toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should take these recalled toys away from young children immediately and contact Tangame Toys for information on how to dispose the product or components for a full refund.



## *IKEA BLAVINGAD Fishing Games*

**Hazard:** A small metal rivet within a wooden play piece can come loose and detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled BLAVINGAD fishing game and contact IKEA for a full refund.



## *Monti Kids Basket with Balls Toys*

**Hazard:** The swirls sewn onto the exterior of the blue, crocheted ball can separate, exposing small parts, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled toys and contact Monti Kids for instructions on receiving a refund of \$12. Monti Kids is contacting all known purchasers.



## *Delta Enterprise Corp. 2-in-1 Outdoor Kids Swings*

**Hazard:** The swing seat restraint straps can break, posing a fall hazard to young children.

**Remedy:** This recall involves 2-in-1 Outdoor Kids Swings made of plastic with a silhouette of Mickey Mouse, Minnie Mouse or PAW Patrol on top. Consumers should immediately stop using the 2-in-1 Outdoor Kids Swings and contact Delta Enterprise Corp for free replacement straps.



## *Kids Preferred “My First” Disney-Character Figurine*

**Hazard:** The arms or legs on the figurines can detach, posing a small part choking hazard to children.

**Remedy:** This recall involves soft vinyl figurines of Disney Characters: Mickey Mouse, Minnie Mouse, Buzz Lightyear and Stitch. Consumers should immediately take the recalled toys away from children and contact Kids Preferred for instructions on receiving a full refund. Consumers who register for the recall will receive a pre-paid shipping label to return the product to the company for a full refund.



## *Target Cloud Island 4-Piece Plush Toy Sets*

**Hazard:** The tires on the toy vehicles can detach, posing a choking hazard to children.

**Remedy:** Consumers should immediately take the recalled plush toys away from young children and return them to any Target store for a full refund or contact Target to receive a prepaid return label to return the toy set by mail.



### *Diamond Visions Screaming Plush Monkey Toys*

**Hazard:** The eyes on the toy can detach, posing a small part choking hazard to children.

**Remedy:** This recall involves Screaming Plush Monkeys in brown, blue and pink. The monkeys are 23 inches long and make a scream-like sound when the front paw is pressed. Consumers should immediately take the recalled toys away from children and contact Diamond Visions for instructions on how to receive a full refund.



### *Lil Anglers Children's Fishing Rods*

**Hazard:** The fishing rods contain levels of lead that exceed the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health issues.

**Remedy:** This recall involves children's fishing rods sold as part of the Kid Caster No Tangle Combo. Consumers should immediately take the recalled fishing rods away from children, stop using them and contact Lil Anglers for a full refund or free replacement fishing rod.



### *Buffalo Games Chuckle & Roar Ultimate Water Beads Activity Kits*

**Hazard:** If a water bead is ingested, it expands and can pose ingestion, choking and intestinal obstruction hazards inside a child's body, resulting in severe discomfort, vomiting, dehydration and a risk of death to a child.

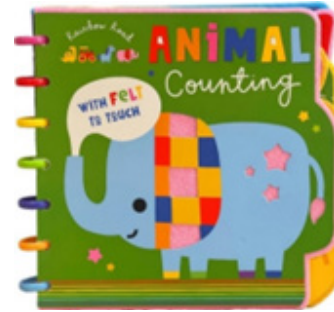
**Remedy:** Consumers should immediately stop using and take the recalled water beads away from children. Contact Buffalo Games for a full refund and instructions on how to return the product in a prepaid mailing package supplied by the company or return the product to any Target Store.



## *Make Believe Ideas Seven Rainbow Road Board Books*

**Hazard:** The plastic binding rings can detach from the books, posing a choking hazard to young children.

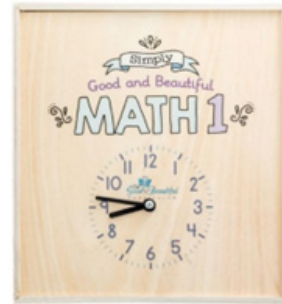
**Remedy:** Consumers should immediately stop using the recalled books and contact Make Believe Ideas to receive a refund in the form of a gift card by registering online at [www.recallrtr.com/rr](http://www.recallrtr.com/rr). Following registration, consumers will be provided instructions on how to dispose of their book(s).



## *The Good and the Beautiful Math 1 and Math 3 Boxes*

**Hazard:** The whiteboard attached to the boxes can become detached exposing sharp edges, posing a laceration hazard.

**Remedy:** Consumers should immediately take the recalled whiteboards away from children, discard them and contact The Good and the Beautiful to receive a free non-metallic replacement. The Good and the Beautiful is contacting known consumers directly.



## *Jetson Nova and Star 3-Wheel Kick Childrens Scooters*

**Hazard:** The rear wheel can loosen or fall off the scooter, posing a fall hazard to children.

**Remedy:** Consumers should stop using the recalled scooters immediately and contact Jetson for a free repair kit.



## *Anker Play Bolt Foldable Children's Scooters*

**Hazard:** The paint on the recalled scooters contains levels of lead that exceed the federal lead paint ban, posing a lead poisoning hazard. Lead is toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should immediately take the recalled scooters away from children, stop using them and contact Anker Play Products for a full refund.



### *Jetson 42-Volt Rogue Self-Balancing Scooters/Hoverboards*

**Hazard:** The lithium-ion battery packs in the self-balancing scooters/hoverboards can overheat, posing a fire hazard.

**Remedy:** Consumers should immediately stop using and stop charging the recalled scooters/hoverboards and contact Jetson for a full refund. Jetson is contacting all known purchasers directly.



### *Calico Critters Animal Sets Sold with Bottle and Pacifier Accessories*

**Hazard:** The bottle and pacifier accessories pose a choking hazard to children.

**Remedy:** Consumers should immediately take the recalled bottle and pacifier accessories away from children and contact Epoch Everlasting Play LLC for instructions on how to submit a photo of the recalled bottle and/or pacifier accessory along with contact information and confirmation of destruction to receive a free replacement accessory.







# Baby & Toddler Goods



## *Skip Hop Silver Lining Cloud Activity Gyms*

**Hazard:** The raindrops on the cloud toy included with the activity gym can detach from the ribbon, posing a choking hazard if a child places it in their mouth.



**Remedy:** This recall involves only the raindrops on the cloud toy sold with the Skip Hop Silver Lining Cloud Activity Gym. Consumers should immediately remove the raindrops on the cloud toy by cutting them off with a pair of scissors, take a photo of the cloud toy with the raindrops removed, discard the raindrops in the household trash, and submit the photo of the cloud toy with the raindrops cut off at [www.skiphoprecall.com](http://www.skiphoprecall.com). Upon receipt of the photo, consumers will be issued a \$10 Skip Hop gift card and a free shipping code.

## *Meiling Hou Crib Bumpers*

**Hazard:** Infants can suffocate if they roll or move on the crib bumper in a position that obstructs breathing. Padded crib bumpers are banned under federal law.



**Remedy:** Consumers should immediately stop using the recalled crib bumpers and contact Meiling Hou for a full refund. Consumers who purchased the crib bumpers will be asked to cut the tie strings of the crib bumper and send Meiling Hou a photo of the destroyed product at [houmeiling111@outlook.com](mailto:houmeiling111@outlook.com). Upon receipt of the photo, consumers will be issued a full refund of the purchase price. Meiling Hou is contacting all known purchasers directly.

## *Primark Recalls Children's Bamboo Plates*

**Hazard:** The recalled children's bamboo plates have elevated levels of lead and formaldehyde. Both lead and formaldehyde are toxic if ingested by children and can cause adverse health effects.

**Remedy:** This recall involves Primark bamboo plates in the shape of a bunny, bear, Winnie the Pooh and a rainbow. Consumers should immediately take the recalled plates away from children, stop using them and return them to a Primark store for a full refund or consumers can contact Primark for instructions on how to properly dispose of the product to also receive a full refund.



### *TOMY Boon Flair and Flair Elite Highchairs*

**Hazard:** The bolts used to secure the seat of the recalled highchair to the pedestal base can become loose and allow the seat to detach, posing a fall hazard.

**Remedy:** Consumers should stop using the recalled highchairs immediately and contact TOMY for a free repair kit.



### *Clark Associates Lancaster Table & Seating Brand Highchairs*

**Hazard:** The highchairs can break, posing a fall hazard to children.

**Remedy:** This recall involves highchairs in black, mahogany, natural and walnut finishes. Consumers should immediately stop using the recalled high chairs and return them to any of the Restaurant Store locations in Pennsylvania, New Jersey, Delaware or Maryland or contact Clark Associates for a free replacement or refund in the form of a store credit and instructions on how to properly discard the product. Consumers will be asked to submit a photo of the dismantled or destroyed product and dispose of it.



### *TopGlore Narskido Infant Bath Seats*

**Hazard:** The bath seats fail to meet the federal safety standard for infant bath seats, including requirements for stability and leg openings, and can tip over while in use, posing a drowning hazard to babies.

**Remedy:** Consumers should immediately stop using the recalled infant bath seats and contact TopGlore through the Amazon platform for a full refund of the purchase price. Consumers will be asked to dispose of the recalled product. TopGlore and Amazon are notifying all known purchasers directly through the Amazon platform.



### *Fisher-Price Rock 'n Play Sleepers*

**Hazard:** Infant fatalities have occurred in the Rock 'n Play Sleepers, after the infants rolled from their back to their stomach or side while unrestrained, or under other circumstances.

**Remedy:** This recall involves all models of Rock 'n Play Sleepers. Consumers should stop using the Rock 'n Play immediately and contact Fisher-Price for a refund or voucher. More than 30 fatalities are reported to have occurred in the Rock 'n Play sleepers.



### *Kids2 Rocking Sleepers*

**Hazard:** Infant fatalities have occurred in the Rocking Sleepers, after the infants rolled from their back to their stomach or side while unrestrained.

**Remedy:** This recall involves all models of Kids2 Rocking Sleepers. Consumers should stop using the rocking sleeper immediately and contact Kids2 for a refund. More than 15 infant fatalities are reported to have occurred in the Kids2 Rocking Sleepers.



### *HONEY JOY Infant Swings*

**Hazard:** The swing violates the Safe Sleep for Babies Act because the product was marketed for infant sleep and has an incline angle greater than 10 degrees. Infant fatalities have occurred in inclined sleepers, after the infants rolled from their back to their stomach or side while unrestrained, or under other circumstances. The swing also violates the Safety Standard for Infant Swings.

**Remedy:** Consumers should immediately stop using the recalled infant swing and contact HONEY JOY for instructions on how to receive a full refund and properly dispose of the product. HONEY JOY and Amazon are contacting all known purchasers.



## *Target Pillowfort Weighted Blankets*

**Hazard:** A young child can become entrapped by unzipping and entering the blanket, posing a risk of death by asphyxiation.



**Remedy:** This recall involves Pillowfort Weighted Blankets that come in eight prints or colors including unicorn white, space navy, pink, gray, buffalo plaid red, blue constellation and unicorn pink. The blankets weigh 6 pounds and measure 60 inches long and 40 inches wide with a removable, washable cover. Consumers are urged to stop using the recalled weighted blankets immediately and contact Target for a refund.

## *TJX Baby Blankets*

**Hazard:** The threads in the recalled woven baby blankets can come loose and detach posing choking, entrapment and strangulation hazards.

**Remedy:** Consumers should immediately stop using the recalled baby blankets and return them to any HomeGoods, Marshalls or T.J. Maxx store for their choice of a full refund or store credit.



## *Simplex3 Toddler Towers*

**Hazard:** The towers can tip over while in use posing fall and injury hazards to young children.

**Remedy:** This recall involves Simplex3 Toddler Towers sold in the colors espresso, white and gray. Consumers should immediately stop using the recalled Toddler Tower, take it away from children and contact Simplex3 to receive a free set of stabilizing bases to be attached to the toddler tower.



### *Restwell Room & Board Crib Mattresses*

**Hazard:** The recalled crib mattresses fail to comply with multiple provisions of the Federal Safety Standard for Crib Mattresses, including the firmness test and missing warnings and labels. The product poses a suffocation hazard to infants.



**Remedy:** Consumers should immediately stop using the crib mattresses and contact Room & Board to receive a full refund. Restwell Mattress Co. and Room & Board are contacting all purchasers directly and will arrange for pick up at no charge.

### *Pottery Barn Kids Penny Convertible Crib*

**Hazard:** The cribs' end panel can become loose exposing sharp edges, posing a laceration hazard to children.

**Remedy:** Consumers should immediately stop using the recalled cribs and contact Pottery Barn Kids to schedule delivery and installation of new end panels for the crib and removal of the old end panels or a full refund. The company is contacting all known purchasers.



### *Crate and Barrel Thornhill Baby Cribs*

**Hazard:** The mattress support pins can become loose or not fit properly causing the mattress to fall, posing a fall hazard.

**Remedy:** This recall involves Thornhill Dark Brown and Natural Baby Cribs. The cribs have a dark brown wash finish and gold-capped feet. Consumers should immediately stop using the recalled cribs and contact Crate and Barrel for a full refund or free replacement. Crate and Barrel is contacting all purchasers directly.



***Phillips Avent Digital Video Baby Monitors***

**Hazard:** The rechargeable lithium-ion batteries in the Parent Unit monitors can overheat during charging, posing a risk of burns and property damage.

**Remedy:** Consumers should immediately stop using the Digital Video Baby Monitors and contact Philips Avent for a free replacement.



***Patagonia Recalls Patagonia Infant Capilene Midweight Base Layer Sets***

**Hazard:** The snaps in the bodysuit of the recalled base layer sets can detach, posing a choking hazard if mouthed by infants.



**Remedy:** This recall involves sets sold in sizes 0 months through 24 months in five designs: pink and white with “My Planet”, pink hearts and pink trim, blue with “Patagonia” and “Fun Hogs”; pink with small graphics; pink with “Patagonia Mountain Kids”.



Consumers should immediately stop using the sets and contact Patagonia for a full refund. Patagonia will provide consumers with prepaid labels to return the recalled product, and a full refund upon receipt of the product.

***Akerson Enterprises Kindred Bravely Bamboo Nursing Hoodie***

**Hazard:** The drawcord on the hoodies has small plastic caps that can be swallowed by a nursing baby posing a choking hazard.

**Remedy:** Consumers should immediately stop using the recalled nursing hoodies, cut the fully extended drawstring cords and discard the cords. Consumers can also request a \$75 store credit by filling out an online form at [www.kindredbravely.com](http://www.kindredbravely.com) and providing a photo of the cut drawstring cords and company branding.



## *WeeSprout Baby Sleep Sacks*

**Hazard:** The zipper can detach from the sleep sack, posing a choking hazard.

**Remedy:** This recall involves sleep sacks of all sizes in the colors blue dusk, dotted rose, gray stitch and rosemary stitch. Consumers should immediately stop using, take the recalled sleep sack and cut it in half with a pair of scissors, take a photo of it and discard it in the household trash. Consumers can contact WeeSprout to receive a \$17 refund credit in the form of a gift card. WeeSprout is contacting all known purchasers.



## *NUK First Choice 240 mL Glass Baby Bottles*

**Hazard:** The markings on the outside of the bottles contain levels of lead that exceeds the federal lead content ban.

**Remedy:** Consumers should immediately stop using the recalled glass baby bottles and contact NUK for information on how to return the bottle and receive a full refund.



## *Green Sprouts Stainless Steel Bottles and Cups*

**Hazard:** The recalled stainless-steel bottles and cups bottom base can break off, exposing a solder dot that contains lead, posing a lead poisoning hazard to the child.

**Remedy:** Consumers should immediately take the recalled stainless steel bottles and cups away from children. The base of the bottles and cups should be discarded. The plastic and silicone components can be kept as they are unaffected by this recall. Contact Green Sprouts for a full refund in the form of store credit or your money back. Green Sprouts is contacting all known purchasers directly.





## *Mockingbird Single Strollers*

**Hazard:** The lower side of the stroller frame can crack, posing a fall risk to children in the stroller.

**Remedy:** Consumers should immediately stop using the recalled Single strollers and contact Mockingbird to receive a free frame reinforcement kit, which includes two frame clamps that attach to the sides of the stroller to reinforce the frame. Mockingbird is contacting all known purchasers directly.



## *Mockingbird Single-to-Double Strollers*

**Hazard:** The lower side of the stroller frame can crack, posing a fall risk to children in the stroller.

**Remedy:** Consumers should immediately stop using the recalled Single-to-Double strollers and contact Mockingbird to receive a free frame reinforcement kit, which includes two frame clamps that attach to the sides of the stroller to reinforce the frame. Mockingbird is contacting all known purchasers directly.



## *CaTeam Canvas Baby Hammock Swing*

**Hazard:** The inclined sleeper is a banned hazardous product under the Safe Sleep for Babies Act since the product was marketed for infant sleep and has an incline angle greater than 10 degrees. Infant fatalities have occurred in inclined sleepers after the infants rolled from their back to their stomach or side while unrestrained, or under other circumstances.

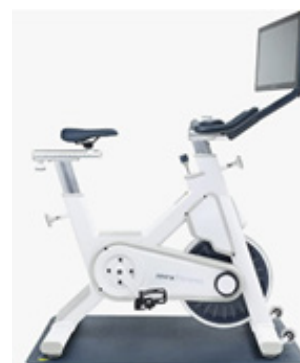

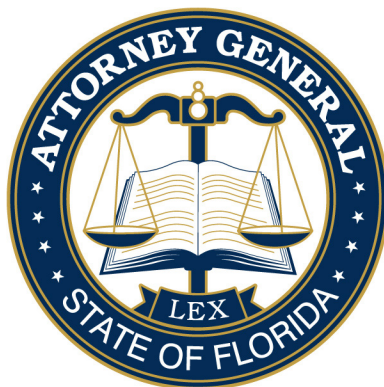
