IV. INTERVIEW OF RESIDENTS OF COLORED QUARTERS, MIMS, FLORIDA

The following investigation was conducted by Special Agents ROBERT E. SUNKEL and ROBERT T. NISCHWITZ on February 26, 27 and 28, 1952, at Mims, Florida.

BASIS: Contact residents of all houses in colored quarters at Mims to obtain additional information of value to instant investigation.

Headdents of all houses in the colored quarters were interviewed and asked if they had heard anything about the two white men who had appeared at BURNETT's store on May 17, 1951, inquiring for HARRY MOCHE's residence. They were also asked if they had heard of anyone who had seen any automobiles or persons in the vicinity of the MOCHE home just prior to the bombing. In addition to these specific questions, each person was asked generally whether he or she had any information of value to instant investigation. All were advised to contact the FBI immediately should any information come to their attention in the future.

In order to conduct this investigation a sketch map was made of the colored quarters and on it each house, was placed in its relative position in the quarters. It should be noted only the main street designated as Church Street has a name. None of the houses has a number. For purposes of control these houses have been numbered on the map. This map is being maintained in the Miami file.

It should be noted that many of the individuals recontacted during the course of this investigation have been previously contacted and have furnished information in instant case which has been reported previously. These persons are designated by an asterisk after their names in the list appearing below.

Except for information previously received and reported, none of the individuals contacted were able to furnish any information of value to this investigation. Their names are being set forth in alphabetical order and opposite each name appears a number corresponding to the number of the house in which that person resides as reflected by the above mentioned sketch map.

On 1/7/80, at the request of USA Gary Betz, a meeting was held in Mr. Betz' Office, at which were present USA Betz, SAC Philip A. McNiff, Brevard County State Attorney Douglas Cheshire, State Attorney Investigator "Buzz" Patterson, and Supervisor Robert H. Dwyer.

Mr. Cheshire advised that for some time now his investigator, Mr. Patterson, has been investigating captioned matter. Patterson has been talking with an individual who is quite ill but who was a member of the Klan at the time of captioned double murder, and who has identified the two individuals who placed the bomb. Both were members of the Klan and died a relatively short time thereafter. One of Klan and died a relatively short time thereafter stated the two individuals committed suicide. Mr. Cheshire stated that the individual has not admitted any complicity on his own part in the crime.

Cheshire said that some time ago, through arrangements with the Civil Rights Division of the Department of Justice, Mr. Patterson was allowed to review FBI files in this matter at the Justice Department. He was not furnished the identity of any informants in this case although from the T symbols in the file, it appeared that the FBI had a number of informants who were contacted during an extensive investigation. He is concerned that his source of information might have been an FBI informant; however, at this time he does not wish to furnish his source's identity so that it could in fact be checked.

He is interested in once again reviewing the file as completely as possible so as to compare the file with the information he has most recently obtained from his source. The file also indicates that the Case Agent was probably a Miami based Agent named Tobias Matthews. He would like to locate Mr. Matthews if at all possible.

USA Betz stated that he would check with the Justice Department and do what he could to make the file available for review. SAC McNiff stated that efforts would be made to determine the current whereabouts of Tobias Matthews.

Although Cheshire did not identify his source, he said the source had been the head of the Klan "Wrecking Crew" and had been indicted for a crime similar to captioned crime. Finally, he said that this individual is almost terminally ill and extremely difficult to deal with because of a mercurial disposition.

ADDENDUM OF SUPR. ROBERT H. DWYER 1/8/80 RHD:rab

On 1/8/80, I was able to ascertain that former SA Tobias Matthews was transferred from Miami to Los Angeles, where he retired and is believed now to be living in Glendale, California. He did not join the ex-Agents' association and thus there is no address for him.

I found out further, however, the Agent who was actually running this case on the scene was former SA Frank F. Meech, who now lives at 80 Tropical Shores Drive, Tavares, Florida. This information I furnished telephonically to Investigator "Buzz" Patterson, and he stated that he was most appreciative and would make contact with former SA Meech.

RAYMOND HENRY, JR., General Delivery, Titusville, Florida, appeared at the Ft. Pierce, Florida Resident Agency in the company of CHARLIE FRANK MATTHEWS, local National Association for the Advancement of Colored People (NAACP) Representative. HENRY stated he was a participant in the bombing of the MOORE residence, Mims, Florida, in which MOORE and his wife were killed several years ago.

HENRY was advised of the identity of the interviewing Agents and his basic rights pertaining to interrogation.

HENRY promptly waived these rights as indicated on a signed Advice of Rights - Waiver form, and insisted on furnishing the following signed statements:

"Ft. Pierce, Florida March 2, 1978

"I, RAYMOND HENRY, Jr., 109 South 7th Street, Ft. Pierce, Florida, make the following free and voluntary statement to W. JAMES FRANKLIN and KEITH L. UNDERWOOD who have identified themselves to me as Special Agents with the Federal Bureau of Investigation. No promises have been made to me and since the doctors at the Veterans Administration (VA) Hospital have told me I have only a short time to live, I want to get this off my conscience.

"I was born in Terre Haute, Indiana, graduated from the University of Texas with a degree in chemical engineering, and am the recipient of the Medal of Honor as a result of military service in World War II on Iwo Jima.

"I hereby say this to clear my conscience and also to make the guilty pay for what they have done, it's been many years ago but I still want to tell the truth of what happened.

In addition to the signed statements furnished by HENRY, HENRY advised as follows:

He obtained his knowledge of explosives during his service with the Third Marine Brigade, U.S. Marine Corps, and made the bomb himself. He stated this bomb filled a box approximately 4" X 5" and consisted of black powder, % stick of dynamite, muriatic acid, and sulphuric acid.

HENRY advised the fuse to this device was a trail of liquid sulphur and he and BILL BOYD actually set the bomb under MOORE's bed.

HENRY continued that the bombing took place in the springtime, around Easter, that it was Klan instigated, and that LANIE NORVELL was the head of the local Klan.

On January 13, 1992, Inspector John Doughtie conducted a tape recorded interview with former Lake County Sheriff Willis V. McCall regarding matters related to the ongoing investigation of the 1951/52 deaths of Harry T. Moore and his wife Harriett. A summary of the interview findings are as follows:

- * Willis McCall denied any involvement in the bombing and subsequent deaths of Harry Moore and his wife. Further, McCall advised that he does not know who was responsible for the bombing/murders.
- * McCall advised that he has never been a member of the Ku Klux Klan.
- * McCall advised that he never instructed Klan members not to talk to the FBI in an effort to obstruct the investigation being conducted during the 1950's.
- * McCall advised that he does not know Raymond Henry Jr. and that he never attended a meeting with Henry when the bombing of the Moore residence was allegedly planned. Further, McCall advised that he did not finance the bombing incident and never provided any vehicles for use during the bombing. McCall also advised that he does not know an individual named Robert "Bob" Case and never attended any meeting at a trailer owned by Case for the purpose of planning the bombing. McCall advised that he does not know any black individual known as "Cowboy."
- * McCall advised that he knows Lannie Norvell as being the former sheriff of St. Lucie County. Further, McCall advised that he has no information which would indicate Norvell was responsible for the Moore bombing, nor does McCall know if Norvell was ever a member of the Ku Klux Klan. McCall advised that he does not recall any individuals by the name of Bill Boyd, J.E. Parker, or Woodrow Atkinson.

- * McCall advised that he does not know Ed Spivey or Joseph Cox.
- * McCall advised that he does not know Tillman Belvins or Earl Brooklyn.
- * McCall advised that he does not know Sydney Hopper or Cecil Langdale.
- * McCall advised that he knew David Starr as being the former sheriff of Orange County. However, McCall advised that he had no knowledge of Starr being a former member of the Ku Klux Klan.
- * McCall advised that he knew H.T. Williams as being the former sheriff of Brevard County. However, McCall advised that he had no knowledge of Williams being a former member of the Ku Klux Klan.
- * McCall advised that he did not know Harry T. Moore but knew of his civil rights activities.
- * McCall advised that he does not know Frank Harrington.
- * McCall advised that he had no knowledge of matters regarding the Creamette `bombing which occurred in Orlando, FL during 1951.
- * McCall advised that he does not recall having ever met any of the individuals indicted for perjury by the federal grand jury reviewing matters related to the Moore bombing during the early 1950's.

Note: When Willis McCall advised that he did no know an individual, he also clarified the remark by indicating he did not "recall" the person.

As previously indicated, the interview with Willis McCall was tape recorded. The tape recording or interview transcript should be reviewed for complete details regarding the interview content. The interview transcript will be filed as part of a separate IR. The tape recording was placed within the IA section of the case file.

JD John Doughtie WM Willis McCall

JD This will be an interview. The date of the interview will be January 13th, 1992. This is Inspector John Doughtie of the Department of Law Enforcement. The individual being interviewed will be former Lake County Sheriff Willis McCall. Mr. McCall, you understand that this interview is being recorded. Is that correct?

WM Oh yes.

JD What I want to talk to you today about is matters related to the 1951, ah, bombing and deaths of Harry T. Moore and his wife, Harriett Moore in Mims, Florida on Christmas, December 25th, 1951. And you're agreeing to meet with me today voluntarily, is that correct?

WM Say what?

JD You're, you're volunteering, going to meet,

WM Oh yes. Oh yes.

JD To get right to the point, a lot of articles have been written over the past few years related to your possible involvement in the bombing deaths of Harry Moore. I'm just going to ask you directly. Were you responsible for the death of Harry T. Moore?

WM Definitely not.

JD Were you involved in the bombing?

WM No sir.

JD Do you know who was responsible for the bombing?

WM No sir, I don't.

JD Do you feel the Ku Klux Klan was responsible for the bombing?

WM Well I, that's just a, that's, I suppose they could 've been. I don't know. I don't know that they were. It sounds like it, but,

JD Were you,

WM Could 've been somebody else, could 've been some of these henchmen.

JD Were you a member of the Ku Klux Klan?

- WM No sir. But I had an invitation to join. But I never did.
- JD Do you know which group that would 've been? Out of what area?
- WM No sir, I don't. I know what area, you know, but I don't know. Don't know what the group. I don't know a name of it.
- JD Well...what area would it have been?
- WM This, this area here.
- JD Lake County and general area here.
- WM Yeah, general, central Florida.
- JD Central Florida. Do you know when that was?
- WM No, I don't.
- JD Um hmm. What years were you a sheriff?
- WM I was sheriff in nineteen, I was elected in '44 and took office in January of '45 and went out of office in '72.
- JD So you served as sheriff of Lake County for 28 years?
- WM Twenty-eight years. I was under suspension that last part of '72, but I was still the sheriff of course until the term was up.
- JD Did you ever meet with klan members and instruct or direct them not to talk to FBI during the course of their investigation in the Harry T. Moore bombing?
- WM Not for that purpose. And not that I recall that I did that. But if anyone ever asked me if they had to talk to someone I had to tell 'em that they didn't have to unless it was under court order to do so.
- JD Were you talking to them in a, in a, for the purpose of trying to obstruct the investigation being conducted by the FBI?
- WM No sir. No sir. I never did that.
- JD Did you ever know a guy by the name of Raymond Henry Jr.?
- WM If I ever did I don't recall it. I had a lady yesterday morn, yesterday at noon. I was having lunch. My wife didn't feel like fixing anything. She had the flu and I went up there and this lady come by and passed by and kissed me on the forehead and said there's my favorite sheriff. And when I thought she'd gone over and sit down some and I, and I asked the man who's sitting there who she was and he didn't know. I don't know her yet and then when I was going to try to go and ask her, she was on her way out...evi, evidently and she left. I was going to ask her who she was and tell her her face was familiar but her name wasn't, but couldn't attach a name to it. But I see people all the time that I'm supposed to know, speak

- to me, "Oh, you remember me. You were comin' down that house one time and arrested so-and-so and so-and-so." So, you (inaudible) I can't remember...I remember a lot of 'em, but I don't remember it all.
- JD Raymond Henry was an individual who came forward back in 1978 and advised that he had knowledge or information related to the bombing of the Moore residence and he laid out a scenario of how the bombing was done and a portion of the bombing dealt with the fact that you financed or bankrolled, ah, the bombing of Harry Moore's house.
- WM That's ridiculous. I never have. I couldn't even bankroll something like that today, you know, I'm in better shape now than I was then.
- JD So, what you're telling me is that you had no involvement in bankrolling,
- WM Never had no,
- JD ...and bombing.
- WM ...no involvement in bankrolling.
- JD He said that you attended a meeting where the bombing of, of Harry Moore's residence was planned and it was in a trailer over in the Fort Pierce area. Ah it was the trailer, or, yeah Fort Pierce, it was a trailer owned by a guy by the name of Robert "Bob" Case. Do you know a Bob Case or Robert Case?
- WM No sir. If I ever met him I don't remember. Then I never have been in a klan meeting in a trailer in Fort Pierce. I've never been in that.
- JD Do you know Lannie Norville?
- WM Norville was a sheriff at one time.
- JD Right, he had been a, former sheriff of St. Lucie County.
- WM Yeah, I know him.
- JD Did you ever plan the bombing of Harry T. Moore, ah, with Lannie Norville?
- WM No sir.
- JD How about Bill Boyd? Did you ever know him? He was a deputy in St. Lucie County.
- WM No I never, I might have known him at that time but I,
- JD How about J.E. Parker?
- WM Parker? Was he a sheriff?
- JD I believe he would have been either a policeman or a deputy in either St. Lucie or the Fort Pierce area.

- WM I met officers all over the state during my course of time, tenure in office residing. I don't recall unless I happened to...like the sheriff, I remember him.
- JD How about Woodrow Atkinson? Does that name ring a bell to you?
- WM No, but there's Atkinson here in Umatilla. But they're no, they're not any Ku Klux Atkinsons.
- JD So what you're telling me is these individuals I've just named being Bob Case, Lannie Norville, Bill Boyd, J.E. Parker and Woodrow Atkinson, you don't recall ever meeting these individuals?
- WM I don't ever recall ever meeting, no sir.
- JD And what you're telling me is that you never planned to murder Harry T. Moore with these individuals?
- WM Them or anyone else.
- JD And also you didn't finance the murder.
- WM No sir. I wouldn't do that.
- JD Did you provide vehicles that were utilized on the evening of the bombing?
- WM Oh no sir.
- JD This guy, ah, Raymond Henry, says that you provided three black sedan vehicles that were utilized, ah, for the, to enable them to do the bombings.
- WM Where did he come up with such damn lies as that?
- JD Did you ever know of,
- WM I can see why there has been some talk now.
- JD Did you ever know a black individual known as cowboy? Or the nickname, cowboy?
- WM Cowboy? I,
- JD Well let me ask you this, if, if Raymond Henry was to come forward to law enforcement today and say that he was present when the bombing occurred and that you helped finance it and you provided the vehicles and Lannie Norville, ah, Bill Boyd, J.E. Parker and Woodrow Atkinson were all involved. That would essentially be incorrect?
- WM I'm, I'm pretty sure it would with some of the ones you name, Norville, I don't believe would have done it.
- JD Do you know Norville to ever 've been a member of the klan?

- WM I don't know that he was. I don't know that he was not. I don't know that he was 'cause I don't know.
- JD Did,
- WM I never discussed it with him.
- JD Did you ever attend a meeting where the murder of Harry T. Moore was planned at a klan meeting in Stone Mountain, Georgia?
- WM No sir, I've never been to a meeting in Stone Mountain, Georgia. I've been to Stone Mountain, Georgia two, three years ago.
- JD Is that right. And you don't know Henry, Raymond Henry Jr.?
- WM No sir.
- JD Did you ever know a guy by the name of Ed Spivy, or Joseph Cox? That would 've been from the Orlando, Winter Garden area.
- WM I don't recall the two, but I could have. I don't know.
- JD Now Joseph Cox would have been a secretary for the klan out of, ah, Winter Garden, Apopka area back in the early fifties late forties. You don't recall him?
- WM No.
- JD He was interviewed by the FBI in 1952 in the very early portion, several months after the Moore bombing, and he committed suicide the day after he was interviewed by the FBI.
- WM (Inaudible)
- JD But you don't recall him?
- WM I heard, I read, heard reading about it. But I don't recall.
- JD And you don't recall it,
- WM (Inaudible) is when I read about that, it hadn't been too long ago.
- JD Right, it was in the paper here probably last month or so, last two months. And you don't recall a gentleman by the name of Ed Spivy?
- WM No.
- JD Did you ever know, ah, two klansmen by the name of Tillman Belvins, or Earl Brooklyn?
- WM I don't recall knowing anyone by those names, I, I have met people in time but I, they didn't ring a bell with me, not that I remember them. If it had been someone that I knew real well, I think I'd remember.

- JD Do you recall an individual by the name of Sidney Walker Hopper? Or Cecil Langdale?
- WM No, I don't recall the names but then, I'm not sayin' some time or other I didn't meet some of these people somewhere I don't know that that is...I don't believe I did.
- JD Did you know Sheriff David Star?.
- WM Yes sir.
- JD Was Sheriff Star a member of the Klan?
- WM I don't know if he was or not.
- JD You never attended any meetings where he was there?
- WM (Inaudible) no sir.
- JD Did any klan members or other people ever tell you that Sheriff Star instructed or directed them not to provide assistance to the FBI or not to talk to the FBI?
- WM I never heard that though. I went to Dave Star's funeral.
- JD Is that right.
- WM Yeah.
- JD Did you know former Sheriff H.T. Williams from Brevard County?
- WM Yes I knew him. That's the one that didn't have opposition. He never had opposition all the time he was in the sheriff's office.
- JD Did you ever know him to be a member of the Klan?
- WM No sir, I didn't.
- JD Did you know him during the time of the Harry T. Moore bombing investigation from '51 through '55?
- WM He used to, he was still the sheriff then, wasn't he?
- JD Yes sir.
- WM Yeah, I knew him. I knew him all the time he was sheriff, in fact, well I think he was sheriff before I was. And then he went out before I did. He didn't run. He didn't get defeated.
- JD Did you ever discuss matters relating to the Harry T. Moore bombing or the investigation, ah, with Sheriff Williams?
- WM Not, not as...I don't know. Some time or other, the sheriffs meeting, or something, it might have come up and we some, made some remarks. I don't

- recall. 'Cause I've had, discussed it with people the, just occasionally, you know, and not very, not very extensively either.
- JD These would be the sheriffs conferences?
- WM Well it would be the sheriffs conference if I did and, ah, and if, ah, well when it's a talk and in the papers and somebody asked you about it, you talk about it. I never talked to, at length with anybody about it.
- JD Do you have any knowledge that Sheriff Williams would have tried to coverup, ah, or whitewash the investigation being conducted into the bombing of Harry Moore?
- WM It would be awful hard for me to believe that he would do that. He, he was an upright man and he run his office all them years without opposition and as well thought of as he was, it just would be hard for me to believe. I, you know, I'm not one to stand here and tell you, hell yes I know he wouldn't. But, ah,
- JD As far as you know he was not a member of the Ku Klux Klan?
- WM As far as I know he wasn't. But I don't know. I didn't never ask him.
- JD Did you know Harry T. Moore?
- WM No sir.
- JD Had you ever met him?
- WM No sir. Never met him. Never knew him. Never met him or his wife or either one of 'em.
- JD Following the,
- WM If I, If I met him I didn't know him under that name you see.
- JD It's my understanding that following the, the shooting of the two individuals that yourself and another deputy were involved bringing back from Raiford back to Lake County to stand trial in November of '51, following that shooting, that Harry Moore became involved in civil rights or protests or, ah, movements afoot trying to bring justice into that matter. Do you recall Harry T. Moore from that,
- WM I recall his name coming up, yes, about that time. I sure do.
- JD But you never met him yourself?
- WM No sir. Sure didn't.
- JD Did you ever instruct anyone to take care of him? Or that he needed to be taken care of or put out of business, or something to that effect?
- WM No I never, I never, to say (inaudible) that he should have been (inaudible). You know, it was general knowledge that people that got mixed up in that thing around wasn't very popular. I guess you know that.

- JD Um hmm.
- WM And ah, I've heard people say that, that, ah, Martin Luther King ought to have been shot before he was. I've heard that remark made, but the people who made it, I don't think would hire it done or have it done or do it. And ah,
- JD Did you ever know an individual by the name of Frank Harrington? Do you recall that name?
- WM No. Frank Harrington? I might have known him but I don't... I see people a lot of times that know me that I don't know them, you know. I guess they have a reason to remember, maybe, who I was more than I knew who they were.
- JD Back during the original trials that surrounded the burglary, rape of the white lady that resulted in the conviction, I believe, and death sentence on these individuals, it's my understanding that the attorneys who came down to handle that particular case, at some point in time, several of those attorneys, and I believe several reporters, were traveling back to Orlando and you gave 'em a police escort to the Lake County line and then they proceeded on to Orlando. At some point in time leaving the Lake County line it's my understanding that they were chased by several carloads of Ku Klux, Ku Klux Klan members. Do you recall that incident?
- WM I remember the incident, yes. And I remember that they wanted me to give 'em twenty-four hours escort and I remember me telling them that I had my hands full with what was going on here in Lake County and I didn't have the manpower to do it.
- JD Were you involved in the planning of the, the chase itself or anything like that?
- WM No sir. I didn't know anything about it until after it happened. And I don't even know it happened, all I know is they said it happened.
- JD And that's what you have learned afterwards.
- WM Yeah. No I didn't know.
- JD Do you recall any klan members ever telling you they were going to kill one of the, ah, defense attorneys and coming to you to get your permission and you telling 'em not to, not to do that because you had the case one anyone?
- WM No, I might 've told somebody, I said, you know, I've, I've had people say such certain things ought to be done, this ought to be done, that ought to be done. And I've talked against 'em. Yeah, we, we figured we had the case won. You know the, these bunch of curly haired professors up at the University of Florida they wrote big articles about that, I guess you knew about those, or some of 'em, they claim that, they, they kind of insinuate that those boys were innocent and there wasn't even a rape.

- JD As I...I haven't looked too much into that particular case, 'cause that's really not part of what I'm looking into to a great degree. So basically the questions I've asked you so far, you were, what you're telling me is that you weren't responsible for the bombing or the death of Harry Moore. Is that correct?
- WM Definitely not.
- JD And you do not have knowledge of who did?
- WM No sir.
- JD Then the other suspects or names that I have listed that may have been involved, you don't know these individuals?
- WM I don't know 'em, if I ever met 'em I just don't recall it.
- JD Is there anything that I have failed to ask you that you would like to make part of the record at this time?
- WM No, except what I've said that I definitely had nothing to do with it. And if I, my previous conduct would prove that I wouldn't do that, but when I'd take those four Negroes that were involved in that down there, not the four the two, and hid 'em in my own basement, in my own home, to keep the mob from getting 'em,
- JD Is that during the trial itself?
- WM Is was before they were tried. And ah,
- JD In, I believe it was November or maybe September or October of 1951, there was an ice cream parlor over in Orlando known as the Creamette that was bombed or blown up. Do you recall that incident at all?
- WM No sir, I don't recall that.
- JD Were you ever involved in a bombing of an ice cream parlor over in Orlando?
- WM I was never involved in any kind of bombing.
- JD The individuals that were, ah, indicted for perjury following the federal grand jury in about 1953, there was an individual by the name of Ernest Morton, Emmett Hart, T.J. McMennamy, Robert Judah, William Boger, and Harvey Reisner. Do you know any of those individuals?
- WM No. I might 've read about 'em at the time, but I don't know 'em.
- JD Did you ever tell those individuals how to testify?
- WM No sir. Reisner, I've known some Reisners. That name rings a bell with me somewhere. But I don't recall if it does, or connected with that.

- JD If you have nothing else to add, I'm going to go ahead and, all right, let me ask you, now everything you've told me today is the truth? To the best of your knowledge?
- WM To the best of my knowledge everything I've told you is the truth.
- JD I'm going to go ahead and conclude this interview. This would be January 13th, 1992. The time for conclusion of the interview will be 1:45 p.m.

FLORIDA DEPARTMENT OF LAW ENFORCEMENT

INVESTIGATIVE REPORT

On January 15, 1992, Inspector John Doughtie spoke with former Lake County Sheriff Willis V. McCall by phone in an effort to clarify two issues discussed with McCall during the course of the formal interview conducted on January 13, 1992. A summary of these issues and the answers provided by McCall are as follows:

Allegation: During the 1950's trial conducted in Lake County related to Samuel Shepperd and Walter Irvin, Sheriff Willis McCall was alleged to have been approached by Ku Klux Klan member Francis Edward Jackson while at the Courthouse. Jackson allegedly advised McCall that he was going to kill NAACP Attorney Ackerman (first name unknown) but was told not to, as McCall had the case won. (Source: FBI case files)

Answer: Willis McCall advised that he does not know an individual by the name of Francis Edward Jackson and denied that he was ever told by anyone that they were going to kill NAACP Attorney Ackerman.

Allegation: Willis McCall allegedly solicited the assistance of the Ku Klux Klan to "run" the NAACP attorney's out of Florida. Several NAACP attorney's were later chased by vehicles occupied by Klansmen from Lake County to Orange County. (Source: FBI case files)

Answer: Willis McCall denied any involvement in the alleged chase of the NAACP officials and denied that he solicited the Klan to initiate the incident.

Note: The issues described above were discussed during the January 13 interview; however review of the tape recording indicated a need for further clarification.
