Dear Sirs:

We wish to express our opposition to Senate Bill No. 16, sponsored by Senator John E. Mathews of Duval County, which is to be presented again to the Florida Legislature. We oppose this bill for two reasons. In the first place, it seeks to disfranchise a third of the voting population of Florida. In the second place, it would remove the primaries from State control and thus leave our election machinery open to the worst forms of fraud and corruption.

Senator Mathews has frankly admitted that his Bill is designed to keep Negroes from voting in Democratic primaries. He also admits that "the negro in a general election cannot elect a candidate". In short, Senator Mathews is admitting these two facts: (1) that the Democratic Primary is actually THE ELECTION in Florida, and (2) that the General Election in Florida is little more than a formality. Therefore, those citizens who cannot vote in the Democratic Primary are almost completely disfranchised.

But why should the Negro citizens of Florida be disfranchised? Have we not proven ourselves to be loyal citizens of this state? Have we not always rallied to the support of our country whenever a crisis arose? Have we not made our contribution to the progress and development of this state and nation? What have we done so bad and so unpatriotic that we should be denied the fundamental right to vote? Can Florida have a true democracy with one third of its citizens and tax payers disfranchised?

Senator Mathews has written much about the "Communist-inspired, CIO-controlled negro block vote". This is merely a bit of propaganda designed to frighten those who would give all citizens their Constitutional right to vote. The great majority of Negroes do not care anything about communism or any other kind of "ism". I have lived in Florida all of my life, and I know most of the leading Negro citizens of this state. We are not swayed by any foreign ideas of government. We want a real democracy here at home. We want a fuller enjoyment of all the rights and privileges guaranteed by the Constitution. We want to vote when voting really counts. We want to help elect those officials who have direct control of our every-day affairs.

Negroes do not seek to control any election. We just want free participation in the affairs of our government. In a true democracy, the will of the majority always prevails. Minorities gain control only when the democratic process is stifled. That is what happened in Germany.

Removing the primaries from State control will expose Florida politics to the worst forms of fraud and corruption. Political bosses and cliques can more easily get control of our elections.

Passage of the Mathews Bill will help to promote Fascism and Communism in our state. If we are to enjoy that type of democracy described in the Declaration of Independence and the Constitution of the United States, we must have free and unfettered elections for all citizens, without regard to race or creed. We therefore urge you to help defeat the Mathews Bill and thereby help to maintain in Florida a "government of the people, for the people and by the people".

WINTER PARK, FLORIDA March 16.— Members of the non-partisan Florida Voters' League have just had a referendum on the question, "Should the State leave to political parties full control over primaries?" In the postal ballot, sent to all League members, 97 per cent of those voting opposed abandoning state control, and wanted the League to oppose such a change. Accordingly the League Executive Board today issued the following statement.

Why Political Parties Should Not Have Sole Control Over Primaries.

1. A primary uncontrolled by the State is far more likely to be manipulated, and dishonestly, than is one subject to state control.
2. An uncontrolled primary must be financed by a charge upon voters (the old undemocratic poll tax in a new form) or by a large fee charged candidates, thus favoring rich aspirants for office.
3. The proposal is a step away from democracy and toward control by a special group. As such it is a threat to all minority groups. If we permit an all-white primary, which is the purpose of this project, we can logically and easily go on to an all-Christian primary, an all-Protestant primary a native-born-of-native-parents primary, a red-suspenders primary. Through such a step-by-step method the Nazis, at whom men once laughed, destroyed democracy in Germany.
4. The primary needs no "protection" from voters who happen not to be white. Thousands of them are intelligent and many are well educated. They have the same wish for good government that others have.
5. It is unnecessary as a means to protect the primary from ignorant voters. Florida needs only make a fair educational test and administer it fairly.
6. In the light of repeated decisions of the Supreme Court on similar projects in Texas, the plan is clearly unconstitutional.
7. High ranking officers in the Democratic Party and in the government of Florida have declared that the State should not seek to evade the law of the land. So have progressive organizations, such as the Florida Section of the Southern Regional Council, and the Southern Conference for Human Welfare.
8. It is not good for the reputation of a state to try to evade the supreme law of the land. In the eyes of America the passage of such a project would put Florida in the class of Mississippi and Georgia, the homes of Bilboism and Talmadgeism. It would make Florida seem much less desirable to high grade winter visitors and potential citizens from outside the state.
