**MODIFIED FINAL JUDGMENT**

The Court hereby finds the Office of the Attorney General (the “Attorney General”) is entitled to a Modified Final Judgment against Defendants, GNA HOUSEKEEPING, LLC, D/B/A FLORIDA STATE COMPLIANCE CENTER, ZACHERY PECK, and KATHREN PECK, as follows:

1. **FINAL JUDGMENT** is hereby entered on behalf of the Attorney General and against the Defendants, GNA HOUSEKEEPING, LLC, D/B/A FLORIDA STATE COMPLIANCE CENTER, ZACHERY PECK, and KATHREN PECK.
2. **IT IS ORDERED AND ADJUDGED** that:


- a. The Attorney General recovers from Defendants, GNA HOUSEKEEPING, LLC, D/B/A FLORIDA STATE COMPLIANCE CENTER, ZACHERY PECK, and KATHREN PECK, jointly and severally, the sum of \$53,580.00 in consumer restitution; \$91,000.00 in civil penalties; and \$30,155.00, in attorneys' fees and costs for a total of \$174,735.00 that shall bear interest at the statutory rate of 4.5% per year, for which let execution issue.
- b. The asset freeze entered by this Court on July 2, 2015 is dissolved for the purpose of transferring the funds held in Defendants' PNC bank accounts ending in Nos: 8545 and 1486; Defendants' Wells Fargo bank account ending in No: 5436; and any other bank accounts of Defendants frozen pursuant to the July 2, 2015 Order, to the Attorney General.
- c. The funds shall be paid by wire transfer, certified funds or cashier's checks, payable to the **Department of Legal Affairs Escrow Fund ("Escrow Fund")**, and shall be sent to: Consumer Protection Division, Office of the Attorney General, The Capitol, PL-01, Tallahassee, Florida 32399.

d. Any amounts released to the Attorney General shall be deducted from the total amount owed by the Defendants to the Attorney General pursuant to this Modified Final Judgment.

All remaining portions of the Final Judgment entered by this Court on May 18, 2017, and the Order Granting Final Summary Judgment entered by this Court on March 31, 2017, shall remain in full force and effect.
