The Office of the Attorney General is pleased to inform you that we have obtained limited funds for partial restitution in our case against **Home Owner Protection Economics a/k/a H.O.P.E.; Deleverage America, inc.; DC Financial; Dennis Fischer; and Chris Godfrey**, Case No. **L11-3-1006**. One of the goals of the Attorney General is to protect consumers against deceptive trade practices, and the repayment to consumers for the losses they suffered due to the actions of this business is an example of what this office does to help protect our citizens.

Our records indicate you may be a potential victim of the deceptive practices of **Home Owner Protection Economics a/k/a H.O.P.E.; Deleverage America, inc.; DC Financial; Dennis Fischer; and Chris Godfrey**. *If you have been victimized by this company, you must submit a completed Claim Form by March 12, 2012 in order to share in the recovery.* All Claim Forms **MUST** include supporting documents (*receipt, account statement, etc.*) showing the amount of loss. Consumers must not have received a refund or reimbursement through any other means such as charge back or fraud claim with the consumer's financial institution. If you received a partial refund from an alternate means, then please clearly describe the amount of the partial refund and include any supporting documents (*cleared check, financial institution statement, etc.*) showing the amount of the partial refund. Your original signed Claim Form with all supporting documents must be mailed and post-marked no later than **March 12, 2012** in order to be included in this recovery.

If you qualify for a distribution, the amount of your recovery has not yet been determined. We are unable to predict the precise amount that will be distributed to any claimant. We anticipate that the distribution to the approved and timely mailed claims will be made in mid-April 2012. Please note that an individual claimant's recoveries will be considerably less than the actual amount of your loss.
