# INTRODUCTION AND OVERVIEW

This report covers the period from July 1, 2004, through June 30, 2005. It includes an overview of the program functions and serves as the statutorily mandated annual report pursuant to Section 960.045(1)(c), F.S.

The Crimes Compensation Act was enacted by the 1977 Florida Legislature, thereby acknowledging the need for government financial assistance for victims of crime. The stated intent of the legislation is ". . . that aid, care, and support be provided by the state, as a matter of moral responsibility" (Section 960.02, F.S.) for crime victims. Accordingly, the division provides financial and direct services to victims of crime, administers federal grants to fund victim services at the local level, and provides comprehensive training for law enforcement and allied professionals.

#### **Statutory Authority**

The referencing authority governing the provision of services to victims of crime is found in Chapter 960, F.S. The Crimes Compensation Trust Fund is administered by the Office of the Attorney General through the Division of Victim Services and Criminal Justice Programs (division). The division is comprised of the bureaus of Advocacy and Grants Management, Criminal Justice Programs, and Victim Compensation. Through the coordination of services, the division seeks to meet the needs of crime victims by providing victim compensation, specialized direct services, training, and technical assistance, and promoting the establishment of local victim service programs throughout the state.

#### Legislative Update

During FY 2004-2005, there were no substantive legislative changes to Chapter 960, F.S., affecting victim compensation. A new section, 960.0015, F.S., addresses the victim's right to a speedy trial and speedy trial demand by the state attorney.


#### **Crimes Compensation Trust Fund**

The Crimes Compensation Trust Fund (trust fund), authorized by Section 960.21, F.S., receives offender generated federal and state dollars to provide services to crime victims. The trust fund is funded primarily by court-ordered assessments from offenders, including a mandatory court cost, a surcharge on fines, and restitution. Florida's share of federal Victims of Crime Act (VOCA) dollars<sup>1</sup> during fiscal year (FY)

2004-2005 totaled \$28,107,000. VOCA funds awarded to Florida consisted of \$19,285,000 for local programs that provide direct services to victims and \$8,822,000 for financial compensation to victims for losses incurred as a result of their victimization.

Appendix A provides a detailed breakdown of contributions to the trust fund by source, county and judicial circuit. Mandated court costs are the major source of receipts in the trust fund, accounting for 79 percent of the \$25,332,301 received from state (nonfederal) sources (See Figure 1). Of the \$50 court cost, the clerk of the court retains \$1 for administrative purposes and forwards the remaining \$49 for deposit into the Crimes Compensation Trust Fund. When appropriate, the division also seeks to recoup compensation awards through courtordered restitution and subrogation.



#### **Crimes Compensation Trust Fund Expenditures**

The total expenditure<sup>2</sup> of state and federal dollars from the Crimes Compensation Trust Fund for FY 2004-2005 was \$45,932,865. The largest expenditure was \$21,519,930 for awards to or on behalf of victims through victim compensation awards, including initial forensic physical exams for sexual battery offenses. The next highest expenditure was \$17,152,233 for VOCA assistance grants awarded to victim service programs. The balance of \$7,260,702 was used to cover salaries and benefits, operating capital outlay, expenses, other personal services, indirect costs, surcharge to general revenue, and refunds. # BUREAU OF ADVOCACY AND GRANTS MANAGEMENT

The bureau provides regional victim advocacy and appellate notification to victims of crime, provides crisis response training and coordination, and also administers the address confidentiality program and federal VOCA assistance grants. As part of the outreach and clearinghouse functions, the bureau maintains a directory of victim service providers throughout the state, which may be accessed through the Attorney General's web page at <a href="https://www.myfloridalegal.com/directory">www.myfloridalegal.com/directory</a>. Other activities include publication of a biennial Legislative Synopsis that provides an overview of Florida laws relating to the rights of victims of crime and maintenance of the protocols for the initial forensic physical examination of adults and children who are sexually assaulted.

#### Address Confidentiality Program

Pursuant to Sections 741.401 through 741.465, F.S., this office provides a substitute mailing address for relocated victims of domestic violence and serves as legal agent for receipt of mail and service of process. In addition, staff provides training and certifies application assistants statewide to assist eligible victims in the registration process. The Address Confidentiality Program is also intended to prevent public access to client information through voting records. Since inception of the program in 1998, there have been a cumulative total of 911 certified participants. This year's activities include:

- 116 participants certified
- 198 applicant assistants trained
- 496 active program participants

#### Advocacy

Regional victim advocates serve as liaison for the Attorney General's Office and local victim service agencies, providing a direct conduit between victim services organizations and this office to promote the awareness of victims rights. To advance the goal of ensuring these rights are afforded to the state's diverse populations, specific outreach initiatives are directed toward the Haitian and Spanish speaking populations in south Florida. To ensure involvement in establishing and maintaining victim service coalitions in the various communities, advocates are located throughout the state and serve geographical areas comprising single or multiple judicial circuits.

### **Appellate Notification**

Pursuant to Section 960.001, F.S., this office notifies victims of the right to be present at relevant proceedings, provides advocate accompaniment to court proceedings, explains the judicial process, informs victims of the decisions rendered by the appellate courts, and provides notice to victims of their right to be present at judicial proceedings. This year's activities include:

- ♦ 3,180 appellate notices provided
- 123 victims accompanied to court proceedings

## **Capital Cases**

Also pursuant to Section 960.001, F.S., this office informs surviving victims and next of kin of the right to be present at judicial proceedings in state and federal courts, offers advocacy and court accompaniment, explains victims rights in the executive clemency process, and coordinates special services during an active death warrant. This year's services involved:

- ♦ 396 cases
- ♦ 648 victims
- 1,208 survivors and next of kin
- 3,413 individual services

#### **Crisis Response**

Through the Attorney General's Statewide Crisis Response program, crisis response teams (CRT) provide immediate crisis response for community crisis situations (e.g., traumatic events that are natural, accidental or deliberate), serves as liaison with other state and national emergency service providers, and develops and maintains protocols for mobilization under various emergency scenarios. This year's activities include:

- 19 crisis response incidents
- 342 crisis responders trained
- 24 trained CRT members in Florida
- 65,284 citizens served by trained CRT members

#### **VOCA Assistance Grants**

The federal VOCA assistance grant program offers funding to local community providers for use in responding to the emotional and physical needs of crime victims, assisting victims in stabilizing their lives after a victimization, helping victims to understand and participate in the criminal justice system, and providing victims with a measure of safety and security. (See Appendix C for a listing of subgrantees and award amounts.) The state's allocation of the federal fund is based on Florida's population in relation to all the other states and designated territories. This year's activities include:

- \$18,836,865 awarded
- 232 programs funded
- \$81,193 average grant amount
- 207,333 victims served through VOCA grants statewide

# **BUREAU OF CRIMINAL JUSTICE PROGRAMS**

The Florida Crime Prevention Training Institute (FCPTI), located within the Bureau of Criminal Justice Programs, provides statewide public education and training programs for law enforcement personnel, school resource officers, victim advocates and other interested persons on crime prevention initiatives, school-based officer programs, victim advocacy and related criminal justice areas. In addition, the bureau administers the Convenience Business Security Act, Crime Stoppers and Urban League grants, and the annual National Conference on Preventing Crime in the Black Community.

### Florida Crime Prevention Training Institute

FCPTI courses are designed to provide comprehensive crime prevention training to Florida's law enforcement community, citizenry and industry to enable them to control crime by denying criminal opportunity and behavior. Authorized in Section 16.54, F.S., the FCPTI Revolving Trust Fund is self-sustaining and is funded by tuition payments paid by training program participants. - ♦ 82 courses
- ♦ 4,709 attendees
- ♦ 460 designations awarded

### **Crime Prevention**

The crime prevention practitioner designation is awarded to those individuals who successfully complete a series of three comprehensive crime prevention courses offered through FCPTI. To maintain the designation, practitioners are required to attend update courses every three years. There are approximately 2,700 crime prevention practitioners throughout the state. During 2004-2005, FCPTI instituted two new designation programs, Elder Crime Practitioner and Crime Prevention through Environmental Design (CPTED) practitioner. Over 20 percent of the state's law enforcement officers have received crime prevention training. The curriculum includes instruction in basic crime prevention, commercial crime prevention, and residential crime prevention. Additional crime prevention training is evolving to respond to current trends and conditions. This year's crime prevention training activities included:

- ♦ 34 courses
- ♦ 925 attendees
- 99 designations awarded

#### **School Resource Officer**

The objective of the School Resource Officer (SRO) training is to enhance the skills of school-based professionals who deal with juvenile issues on a daily basis. The classes are designed for SROs, school administrators and staff, and other professionals who work with students in campus settings. The SRO curriculum includes an advanced training (i.e., salary incentive) course that has been approved by the Criminal Justice Standards and Training Commission. To obtain the SRO designation, officers must complete the 40-hour basic training plus an additional 90 hours of FCPTI juvenile-related courses. SRO classes are usually offered only during the summer months when school is not in session. This year's SRO training activities included:

- 9 training courses
- 271 attendees
- 13 designations awarded
- approximately 213 officers awarded designation since the program's inception

#### **Victim Services**

Victim training programs are designed for novice and veteran victim advocates and allied professionals to enhance crisis intervention skills and increase awareness of available services and resources. The curriculum consists of victim services practitioner designation classes, advanced advocate training, and issue briefings. The designation program is a three-day course designed to improve the knowledge, skills, and abilities of service providers. This designation is valid for three years and may be renewed by providing evidence of 24 hours of out-service training during the three-year period, including advanced advocate training. Advanced advocate training is designed to enhance the skills and abilities of experienced victim service providers. Issue briefings focus on current issues from a local perspective. This year's victim services training included:

- ♦ 39 specialized courses
- 7 victim services practitioner designation courses
- 1,413 participants
- ♦ 348 designations awarded
- approximately 3,100 designations awarded since the program's inception

#### National Conference on Preventing Crime in the Black Community

This annual national conference is a collaborative effort sponsored by this office to provide a focal point in Florida, Georgia, and around the nation on crime issues in the African-American community. Special attention is directed toward initiatives to curb youth violence and to protect victims of crime, and provides a unique opportunity for participants to share their views and experiences on relevant issues in the African-American community. The 20<sup>th</sup> annual national conference, held in Tampa, attracted approximately 2,100 participants from 25 different states, the District of Columbia, and Jamaica.

#### **Urban League Grant Program**

The Florida Consortium of Urban League Affiliates received a state appropriation of \$2,679,163 to develop and implement two proactive initiatives to address and impact crime in the black community. The programs operate in Fort Lauderdale, Jacksonville, Miami, Orlando, Saint Petersburg, Tallahassee, Tampa and West Palm Beach.

The Black-on-Black Crime Prevention Program is a public awareness and education effort to motivate the black community to support, promote and participate in crime prevention programs and activities. The Youth Crime Prevention and Intervention Program targets specific proactive strategies and activities to address and impact the problem of juvenile crime and to foster collaboration and improve communication among various agencies serving youth. This year's activities with these two programs included:

- 41,687 community residents/participants
- 1,599 crime prevention related meetings, workshops, and conferences
- ♦ 2,086 out-of-agency contacts
- ♦ 1,811 volunteers

#### **Convenience Business Security**

Enacted by the 1990 Florida Legislature, the Convenience Business Security Act (Section 812.171, F.S.) governs security standards for convenience businesses. The Office of the Attorney General is required by statute to review and approve the training curriculum used by convenience businesses for training their employees. Since the inception of the program, FCPTI has trained and certified approximately 400 law enforcement officers who make periodic inspections of the convenience businesses in their geographical areas. Violations are reported to and investigated by this office. Continued noncompliance may result in a fine of up to \$5,000 or an injunction for closure of the business. This year's activities included:

- 94 violation complaints processed
- 149 technical assistance responses

#### **Crime Stoppers Grant Program**

Pursuant to Section 16.555, F.S., the Crime Stoppers Act is designed to enhance public awareness of crime prevention methods and train the public in personal safety principles. Section 938.06, F.S., imposes an additional surcharge of \$20 on fines for criminal offenses, which is collected by the clerks of the courts to be deposited into the Crime Stoppers Trust Fund. This funding is apportioned to eligible counties to improve and support the crime fighting programs through official Crime Stoppers organizations. (See Appendix D for a list of programs funded and award amounts.) This year's activities include:

- 27 Crime Stopper organizations funded
- \$2,797,877 awarded
- ♦ 50 counties served

# **BUREAU OF VICTIM COMPENSATION**

Pursuant to Sections 960.03 through 960.28, F.S., the victim compensation program is administered by the Bureau of Victim Compensation. Various types of claims processed by the bureau include victim compensation, property loss, domestic violence relocation assistance, and sexual assault forensic examinations. In addition, the bureau determines eligibility for state institutions claims and administers a toll-free information and referral service for victims of crime.

#### **Victim Compensation Claims**

The claims are received from crime victims who seek financial assistance for economic loss (lost wages, disability, loss of support), funeral expenses, domestic violence relocation, property loss. and reimbursement of other outof-pocket and treatment expenses directly related to a crime injury. (See Figure 2 for a breakdown of awards by type of crime and Figure 3 for a breakdown of awards by payment type.) Program requirements are set forth in Chapter 960.14, F.S. This year's claims activities include:

- ♦ 16,029 claims received
- \$20,458,728 benefits paid



#### **Domestic Violence Relocation Assistance**

In accordance with Section 960.198, F.S., this benefit provides financial assistance to victims of domestic violence who are seeking a safe environment. Each claim must meet the definition of domestic violence pursuant to Section 741.28(1), F.S., and requires the certification of a State of Florida certified domestic violence center. This year's activities include:

- 3,544 claims received
- \$2,335,544 benefits paid

#### **Property Loss**

Pursuant to Section 960.195, F.S., this benefit (up to \$500) is provided to elderly persons or disabled adults who suffer a property loss that causes a substantial diminution in their quality of life. This year's activities include:

- 1,236 claims received
- \$274,911 benefits paid



activities include:

The claimant is notified of the division's decision in writing if the claim is determined to be ineligible. The claimant is granted the opportunity to appeal the decision within 60 days of the denial by submitting a petition which meets the requirements of the uniform rules of procedure, pursuant to Sections 120.569 or 120.57, F.S. A Notice of Rights form is included with each denial notice and may act as a petition. The claimant may submit additional evidence with the petition proving eligibility, and based on this new information, the claim is reconsidered. When a satisfactory petition is received by the division, it is examined to determine whether material facts are at issue which would require the evidence to be weighed by an impartial hearing officer in an evidentiary hearing. The claimant is granted an informal hearing and given the opportunity to make an oral presentation to the Division Director when there are no material facts at issue. This year's appeals activities include:

- 65 claims reconsidered
- 117 final orders issued
- 4 5 oral presentations held
- 5 decisions affirmed by hearing officer
- 4 hearings in circuit court

#### Information and Referral

The division maintains a toll-free information and referral (I & R) service that provides access to crime victims regarding victim compensation, the criminal appeals process, and local victim services. Callers may access this bilingual service at 1-800-226-6667, Monday through Friday, from 7:30 a.m. until 5:30 p.m. This year's I & R line activities include:

- ♦ 24,167 calls received
- 27,130 services provided

#### **State Institutions Claims**

Pursuant to Section 402.181, F.S., the State Institutions Claims Program provides restitution for property damage and direct medical expenses for injuries caused by a ward of the state institutionalized under the Department of Children and Family Services, patients under the Department of Health, and escapees or inmates of the Department of Corrections or the Department of Juvenile Justice. This office approves eligibility for these claims and notifies the claimant and the respective agency of the decision. Payments are made by the respective state agencies. This year's activities include:

- ♦ 365 claims received
- 233 awarded
- ♦ 59 denied
- \$104,970 approved for payment
