**CRIMINAL USE OF PERSONAL  
IDENTIFICATION INFORMATION**

PETER H. WILLIAMS, Statewide Prosecutor for the State of Florida, by and through his undersigned designated Assistant Statewide Prosecutor, under oath, charges that between on or about May 1, 2004 and continuing through on or about January 31, 2005, in the Sixth, Thirteenth, and Eighteenth

Judicial Circuits of Florida, to-wit: Pinellas, Hillsborough, and Seminole counties, **SABRINA MAE LEDBETTER**, did unlawfully, willfully, and without authorization, fraudulently use personal identification information, to-wit: name and/or birth certificate and/or birth date and/or social security number and/or Oregon State issued Driver's License number belonging to Anna Marie Vigue without obtaining her consent which did result in pecuniary benefit, value of services received, or an amount of injury or fraud of \$5,000 or more, and such offense was facilitated or furthered by the use of a public record as defined in s. 119.011, in violation of Florida Statutes 817.568(2)(b) / 817.568(5)(c). ## COUNT 2

### SCHEME TO DEFRAUD

PETER H. WILLIAMS, Statewide Prosecutor for the State of Florida, by and through the undersigned designated Assistant Statewide Prosecutor, under oath, charges that beginning on or about May 1, 2004 and continuing through on or about January 31, 2005, in the Sixth, Thirteenth, and Eighteenth Judicial Circuits of Florida, to-wit: Pinellas, Hillsborough, and Seminole counties, **SABRINA MAE LEDBETTER** did then and there engage in a systematic, ongoing course of conduct, to wit: did engage in a scheme to fraudulently represent herself as Anna Marie Vigue and did obtain checks and/or credit cards and/or gym membership and/or property and/or goods or services with intent to defraud one or more persons, or with intent to obtain property or U.S. currency from one or more persons by false representations, to-wit: Progress Energy and/or Longbranch Apartments and/or GTE Federal Credit Union and/or Bally Total Fitness and/or Beall's and/or Target Corporation and/or Gibson Truck World, and/or Mease Healthcare and/or Progressive Insurance and/or others known and unknown, and did obtain merchandise and/or U.S. currency with an aggregate value of \$20,000.00 or more, in violation of Florida Statute 817.034(4)(a)(2).
