COUNT 1

PETER H. WILLIAMS, Statewide Prosecutor for the State of Florida, by and through the undersigned designated Chief Assistant, under oath, CHARGES THAT on or about May 1, 2006, in the Fourth and Ninth Judicial Circuits of Florida to wit: Duval and Orange Counties, Florida, **JOHN SCOTT SMITH**, did knowingly utilize a computer on-line service, Internet service, or local bulletin board service to seduce, solicit, lure, or entice, or attempt to seduce, solicit, lure, or entice, a child or another person believed by the person to be a child, to commit any illegal act described in chapter 794, relating to sexual battery; chapter 800, relating to lewdness and indecent exposure; or chapter 827, relating to child abuse, contrary to the provisions of Section 847.0135(3), Florida Statutes.

COUNT 2

PETER H. WILLIAMS, Statewide Prosecutor for the State of Florida, by and through the undersigned designated Chief Assistant, under oath, CHARGES THAT on or about May 2, 2006, in the Fourth and Ninth Judicial Circuits of Florida to wit: Duval and Orange Counties, Florida, **JOHN SCOTT SMITH**, did knowingly utilize a computer on-line service, Internet service, or local bulletin board service to seduce, solicit, lure, or entice, or attempt to seduce, solicit, lure, or entice, a child or another person believed by the person to be a child, to commit any illegal act described in chapter 794, relating to sexual battery; chapter 800, relating to lewdness and indecent exposure;

or chapter 827, relating to child abuse, contrary to the provisions of Section 847.0135(3), Florida Statutes.


COUNT 3

PETER H. WILLIAMS, Statewide Prosecutor for the State of Florida, by and through the undersigned designated Assistant, under oath, CHARGES THAT on or about May 1, 2006, in the Fourth and Ninth Judicial Circuits of Florida to wit: Duval and Orange Counties, Florida, **JOHN SCOTT SMITH**, knew or believed that he was transmitting an image, information, or data that is harmful to minors, as defined in Section 847.001, to a specific individual known by the defendant to be a minor in this state contrary to the provisions of Section 847.0138(2), Florida Statutes.

AND SAID OFFENSES OCCURRED IN TWO OR MORE JUDICIAL CIRCUITS IN THE STATE OF FLORIDA AS PART OF A RELATED TRANSACTION OR SAID OFFENSES WERE CONNECTED WITH AN ORGANIZED CRIMINAL CONSPIRACY AFFECTING TWO OR MORE JUDICIAL CIRCUITS IN THE STATE OF FLORIDA.

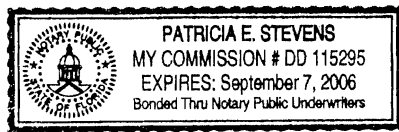
