#### **Holiday Season Shopping Tips**

With so many consumer purchases taking place during the holiday season, it is a good time to be particularly mindful of potential scams, security issues and added costs that may impact your online purchases. Below are tips to keep your money safe while making the most of holiday shopping.

- When shopping online, it is often wise to pay with a credit card instead of a debit card, if possible. Both payment methods allow you to dispute a charge if the merchandise never arrives or is different from what was ordered; however, with a debit card, the purchase is already deducted from your bank account and it may take days or weeks for your bank to reverse the charge.
- When ordering online, ensure that the web browser has a secure connection before inputting or submitting payment information. In the address bar, a padlock should appear to signify that your session is secure.
- Keep your receipts and be sure you understand retailers' return policies and periods so you can return any unwanted items for a full refund.
- Some retailers offer layaway plans or other payment options to allow shoppers to pay for items in installments or at a later date. Before agreeing to such a plan, be sure to ask whether the retailer charges a fee for its program and whether payments and any fees are refundable if the purchase is canceled or returned.
- When purchasing gift cards, check whether there is an additional activation fee, and provide the activation receipt to the recipient. Additionally, consider the retailer's financial situation before buying a gift card. If the retailer closes or declares bankruptcy, the recipient may not be able enjoy the card's value.
- If shopping with a new retailer, check with the Better Business Bureau at <u>BBB.org</u> to determine whether other customers have filed complaints against them.

#### **Tips for Charitable Giving**

While the holiday season is a time for kind and generous deeds, scam artists may seek to take advantage of this spirit of giving. Below are tips to help ensure your charitable dollars do the most good this season.

- Research before donating to a charity. Know if a charity is registered to solicit in Florida, be aware of how much your donation will actually go towards charitable programs as opposed to administrative expenses and check others' feedback on the charity. Websites like <u>FDACS.gov/ConsumerServices</u>, <u>Guidestar.org</u> and <u>CharityNavigator.org</u> allow potential donors to review charities to help make sure the donation doesn't go to a scam organization.
- Do not give your credit card number or bank account information to someone who has called or emailed you unsolicited. If you are interested in donating to a charity that has contacted you, ask them to mail you information about the charity and a pledge form. Legitimate charities should have no problem with this request.
- Watch out for similar sounding charities. It is not unusual for sham charities to choose names that sound like the names of legitimate, well-known charities.
- Know the difference between tax exempt and tax deductible. An organization that is tax exempt does not have to pay taxes, but this does not necessarily mean that a contribution you have made to it is tax deductible. To check whether an organization is eligible to receive tax-deductible contributions, visit <u>Apps.IRS.gov/App/Eos/</u>.

#### **Product Recalls**

During this season of joy and giving, it is important to remain vigilant about the safety of the products brought into your home. What follows is a compilation of 2022-2023 U.S. product recalls in an easy-to-use guide that provides important information on items you may give or receive this holiday season.

This guide reproduces U.S. Consumer Product Safety Commission information and details about recalled toys, baby items, sporting and recreational goods, furniture, and household products that are either designed for, or pose a particular risk to, children and teenagers. These items were among the more than 200 products recalled by the U.S. Consumer Product Safety Commission between October 1, 2022, and October 15, 2023. For more information regarding these products or for a comprehensive list of all product recalls, please visit <u>CPSC.gov</u>.

Dangerous and defective products are the subject of recalls every year. When a product is recalled, the law requires manufacturers and retailers to remove the products from their shelves. However, products subject to recall sometimes slip by undetected and remain in stores; others may have been purchased before a recall was ever issued. Additionally, many products often continue to be offered for sale through online reseller websites well after a recall has been announced. Therefore, it is always important to do your research to make sure that the products you are buying or bringing into your home are safe and free of defect.

Taking a few minutes now to peruse this collection of recalled items will ensure a safer and more enjoyable holiday season for you and yours.





Toys



#### Fisher-Price Little People Mickey and Friends Figures

**Hazard:** The heads of the Donald Duck and Daisy Duck figures can detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the Donald Duck and Daisy Duck figures, take them away from children, and contact Fisher-Price to receive a pre-paid return label to return the two figures and receive a \$10 refund. This recall only involves the Donald Duck and Daisy Duck figures that are part of the figure pack.

#### At Home Procurement Toy Trunk Storage Chests

**Hazard:** The toy trunk storage chests do not contain a lid support feature or ventilation holes, posing entrapment and suffocation hazards.

**Remedy:** Consumers should immediately stop using the recalled toy storage chests, and return them to any At Home store for a full refund.

#### Attom Tech LED Light-up Jelly Ring Toys

**Hazard:** The recalled light-up jelly ring toys contain button cell batteries that fit within CPSC's small parts cylinder, and can be easily accessed without requiring the use of a common household tool. When button cell batteries are swallowed, the ingested batteries can cause serious injuries, internal chemical burns and death, posing an ingestion hazard to children.

**Remedy:** Consumers should stop using the recalled light-up jelly ring toys immediately, take them away from children, and contact

Attom Tech for instructions on how to properly dispose of the product and receive a full refund. Amazon is notifying all known purchasers directly.







#### Sassy Baby Manhattan Toy Brilliant Bee Rattles

**Hazard:** The wooden base can detach from the wooden rod and release the three plastic rings, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled rattles, take them away from children, and return the product to the place of purchase to receive a full refund, or contact Manhattan Toy for instructions on how to return the product to receive a full refund. Proof of purchase is not required to receive a full refund.



#### MGA Entertainment Miniverse Make it Mini Sets with Unused Liquid Resins

**Hazard:** The recalled Make It Mini sets contain resins that, when liquid, can cause skin, eye, and respiratory irritation or sensitization when inhaled, touched, or ingested by children or adults. The resins contain acrylates (hydroxyethylmethacrylate "HEMA" and isobornyl acrylate "IBOA") in amounts prohibited in children's products by the Federal Hazardous Substances Act. After the resins cure, they no longer present this hazard.



**Remedy:** Consumers should immediately stop using any units with unused resins and contact MGA to receive a pre-paid label

to return either: (a) the entire product, including the unused resin, if the product has not been opened, or (b) the unused resins and a photograph of the product, if the product has been opened. Consumers will receive a full refund or replacement product, at the consumer's choice.

#### **Outad Good Life Magnetic Chess Games**

**Hazard:** The recalled magnetic chess games violate the mandatory federal toy magnet regulation because the set contains one or more magnets that fit within CPSC's small parts cylinder, and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.



**Remedy:** Consumers should stop using the recalled magnetic chess games immediately, take them away from children, and contact Outad Good Life for instructions on how to receive a full refund. Consumers can also visit their Temu account, find the relevant order in "Your Orders" and click on the "Return/Refund" button. Outad Good Life is notifying all known purchasers directly.

Shawshank LEDz Squeeze Plush Ball Monsters Toys and Easter Squeezable Toys

**Hazard:** The squeeze ball toy contains a liquid and glitter combination inside a thick membrane. If the membrane is ruptured, the glittery water can splash onto a child's face and body, posing an injury hazard.

**Remedy:** Consumers should immediately stop using the Squeeze Plush Ball Monster Squeezable and Easter Squeezable toys and return the toys to the store where it was purchased for a full refund of \$5 in the form of cash. If it is not possible for a consumer to return the recalled product to a store, they can contact Shawshank



for a postage-paid label to return their toys to Shawshank for a full refund of \$5 in the form of a check.

#### **Thousandshores Theefun Kids Gardening Tool Sets**

**Hazard:** The brown handle strings contain levels of phthalates that exceed the federal phthalate ban. Phthalates are toxic if ingested by young children and can cause adverse health effects.

**Remedy:** Consumers should immediately take these recalled toy gardening tools set away from young children and contact Thousandshores to receive a full refund. Thousandshores and Amazon are contacting all known purchasers directly.



#### Sandford Family Croquet Sets

**Hazard:** The paint or surface coating on the red mallet, blue mallet, red hoop, and winning post contain levels of lead that exceed the federal lead paint ban, posing a lead poisoning hazard. In addition, the coating on the red and blue mallets contains levels of phthalates that exceed the prohibition of specific phthalates. Lead and phthalates are toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should immediately stop using the recalled family croquet sets and contact DOM Sports for information on

how to receive the free replacement parts. DOM Sports and Amazon are contacting all known purchasers.

#### Lovevery Slide and Seek Ball Runs with Wooden Knobs

**Hazard:** The packaging configuration can allow damage to the wooden knob on the Ball Run during shipping and cause it to come loose and detach, posing a choking hazard to children.

**Remedy:** Consumers with a recalled ball run should immediately take it away from children, stop using it, and contact Lovevery for a free replacement. Lovevery is contacting all known purchasers directly.

#### DailySale Recalls High-Powered Magnetic Balls

**Hazard:** The magnetic ball sets contain one or more magnets that fit within CPSC's small parts cylinder, and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract to each other or to another metal object and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.

**Remedy:** Consumers should stop using the recalled magnetic balls immediately, take them away from children, and contact DailySale to receive a pre-paid label to return the recalled magnetic balls for a full refund. DailySale is notifying all known purchasers directly.







#### Stateside Bead Supply High-Powered Magnetic Beads

**Hazard:** The magnetic beads contain one or more magnets that fit within CPSC's small parts cylinder, and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object and become lodged in the digestive system. This can result in



perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.

**Remedy:** Consumers should stop using the recalled magnetic beads immediately, take them away from children and contact Stateside Bead Supply to receive a pre-paid label to return the recalled products for a full refund. Stateside Bead Supply is notifying all known purchasers directly.

#### **Getallfun High-Powered Magnetic Ball Sets**

**Hazard:** The magnetic ball sets contain one or more magnets that fit within CPSC's small parts cylinder and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.




Remedy: Consumers should stop using the recalled magnets

immediately, take them away from children and contact Getallfun.com to receive a pre-paid label to return the recalled products. Upon receipt of the products, consumers will receive a full refund. Getallfun is notifying all known purchasers directly.

## *High-Powered Magnetic Balls (sold Exclusively on Walmart. com)*

**Hazard:** The recalled 5mm magnetic ball sets contain one or more magnets that fit within CPSC's small parts cylinder, and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning, and death.



**Remedy:** Consumers should stop using the recalled magnetic balls immediately, take them away from children and contact Joybuy to receive a pre-paid label to return the recalled products for a full refund. Joybuy is notifying all known purchasers directly.

#### XpressGoods High-Powered Magnetic Balls

**Hazard:** The magnetic ball sets contain one or more magnets that fit within CPSC's small parts cylinder and the magnets are stronger than permitted. When high-powered magnets are swallowed, the ingested magnets can attract each other, or another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.



**Remedy:** Consumers should stop using the recalled magnetic balls

immediately, take them away from children and contact XpressGoods to receive a prepaid label to return the recalled products for a full refund or store credit. XpressGoods is notifying all known purchasers directly.

Fisher-Price Thomas & Friends Wooden Railway Troublesome Truck & Crates and Troublesome Truck & Paint

**Hazard:** The small plastic piece containing a high-powered magnet that connects one train to another can detach or become loose, posing choking and magnet ingestion hazards.

**Remedy:** Consumers should immediately stop using the toys and go to <u>www.service.mattel.com</u> and click on "Recalls & Safety Alerts" for instructions on how to receive a pre-paid return label via email from Fisher-Price. Upon receipt of the returned product, consumers will be sent a full refund.



#### Mary Meyer Bubba Bull Plush Toy

**Hazard:** The eyes of the plush toys can break off, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled plush toys, take them away from young children and contact Mary Meyer to receive a free replacement. Upon return or verification of destruction, consumers will receive a replacement Bubba Bull plush, or a different plush of equivalent value.



### *Litti City and Litti Pritti Dress-Up Playsets and Pretex Slime Eggs*

**Hazard:** Each of the dress-up playsets and the Take-Along Slime Eggs contain levels of certain phthalates that exceed the federal phthalate standard. In addition, the Litti City teacher purse dress-up playset, the Litti Pritti handbag playset, and the slime eggs contain levels of lead that exceed the federal lead content ban. Lead and phthalates are toxic if ingested by young children and can cause adverse health effects.



**Remedy:** Consumers should immediately stop using the recalled playsets and slime eggs and contact Perch for more information on how to dispose of the product and to get a full refund after providing proof of destruction. Perch, Amazon and Walmart will contact all known purchasers directly.

#### The FORT Children's Play Tents

**Hazard:** The magnets used to connect the various pieces of The FORT can become dislodged from their pouches, posing choking and laceration hazards to young children.

**Remedy:** CPSC urges consumers to dispose of recalled children's play tents and NOT to resell or donate them. It is a violation of federal law to sell or distribute recalled products. **The company is no longer in business, so there is no remedy for consumers.** 



#### Dixon Ticonderoga Creativity Street Foam Pattern Rollers

**Hazard:** The recalled foam pattern rollers contain levels of lead that exceed the federal lead content ban in the rollers' handles. Lead is toxic if ingested by young children and can cause adverse health effects.

**Remedy:** Consumers should immediately stop using the recalled foam pattern rollers and take them away from children. Contact Dixon Ticonderoga to receive a pre-paid label to return the recalled product. When the foam pattern rollers are received, consumers will receive a full refund. All known purchasers are being contacted directly by the company or retailer.



#### Yoto Mini Speakers for Children

**Hazard:** The speaker's lithium-ion battery can overheat and catch fire, posing burn and fire hazards to consumers.

**Remedy:** Consumers should immediately stop using the recalled speakers, take them away from children, and contact Yoto to receive a free replacement smart charging cable. Consumers can send a photograph of the old cable cut through the middle to receive a new replacement cord.



#### Fisher-Price Dumbbell Toy in Baby Biceps Gift Sets

**Hazard:** The gray caps on the end of the dumbbell toy can come off, posing a choking hazard to infants.

**Remedy:** Consumers should immediately stop using the recalled dumbbell toy, take it away from young children, and contact Fisher-Price to receive a refund. Proof of purchase is not required to receive a refund for the dumbbell.



#### JAKKS Pacific Children's Mario Kart Ride-On Racer Car Toys

**Hazard:** If the acceleration pedal on the battery-operated ride-on toy becomes clogged with debris, it can stick after the user's foot is removed from the pedal, posing a crash hazard.

**Remedy:** Consumers should immediately stop using the 24V Ride-On cars and contact JAKKS Pacific to receive a free repair kit. The repair kit includes a free replacement pedal with installation instructions.



#### DGL Group Hover-1 Dynamo E-Scooters

**Hazard:** The e-scooter's brakes can fail, posing a risk of serious injury and crash hazard.

**Remedy:** Consumers should stop using the recalled e-scooters immediately and contact DGL Group for instructions on how to receive a full refund. To receive a refund, consumers will be required to provide photographs of their e-scooter's serial number and severed motor cable.

#### **Razor Icon Electric Scooters**

**Hazard:** The downtube of the recalled electric scooter can separate from the floorboard during use, posing a fall hazard.

**Remedy:** Consumers should immediately stop using the recalled scooters and contact Razor to receive a refund or coupon. Consumers with proof of purchase for recalled scooters bought on or after March 11, 2023, can receive a full refund. All other consumers can request a \$700 coupon for a future purchase on razor.com or a \$300 refund.

DGL Hover-1 Helix Hoverboards (Camouflage and Galaxy colors only)

**Hazard:** The recalled hoverboard's lithium-ion battery can overheat, posing a fire hazard.

**Remedy:** Consumers should stop using the recalled hoverboards immediately and contact Hover-1 for instructions as to how to receive a free replacement hoverboard.

#### Future Motion Onewheel Self-Balancing Electric Skateboards

**Hazard:** The skateboards can stop balancing the rider if the boards' limits are exceeded, posing a crash hazard that can result in serious injury or death.

**Remedy:** Consumers should immediately stop using the recalled Onewheel electric skateboards and visit recall. onewheel.com for information about firmware updates for their board.



#### Intellio Toys Bright Builder Fort Kits

**Hazard:** The flashlight on the recalled kits contains button cell batteries in a compartment that can be easily opened without requiring the use of a common household tool. When button cell batteries are swallowed, the ingested batteries can cause serious injuries, internal chemical burns, and death, posing an ingestion hazard.

**Remedy:** Consumers should immediately stop using the flashlights in the recalled fort kits, keep them away from children,



and contact Intellio Toys for instructions on how to receive a refund between \$10 and \$15, depending on the model. Consumers can continue to use the fort kits without the flashlights.

#### Crate & Barrel Hampshire Cribs

**Hazard:** The mattress support pins can become loose and allow the mattress to fall, posing a fall hazard to children.

**Remedy:** Consumers should immediately stop using the recalled cribs and contact Crate & Barrel for a free repair or full refund. Crate & Barrel is contacting all known purchasers directly.



#### RH Baby & Child Jeune French Contemporary Upholstered Panel Cribs

**Hazard:** The cylindrical metal inserts in the crib's wooden frame can become loose and detach, posing a choking hazard.

**Remedy:** Consumers should immediately stop using the recalled cribs and contact RH to receive a full refund of the purchase price, or a new replacement crib with shipping at no charge. RH will provide free pickup of the recalled crib and is contacting all known purchasers directly.



### Henan Ouchang Trading and Xinxiang Junshun Trading on AliExpress Crib Bumpers

**Hazard:** Infants can suffocate if they roll or move on the crib bumper in a position that obstructs breathing. Padded crib bumpers are banned under federal law.

**Remedy:** Consumers should immediately stop using the recalled crib bumpers and contact AliExpress for a full refund. To receive a refund, consumers should destroy the crib bumpers by cutting the straps and the padding and send a photo as proof of destruction. AliExpress is contacting all known purchasers.



#### Zazaba International Grao de Gente Crib Bumper

**Hazard:** Infants can suffocate if they roll or move on the crib bumper in a position that obstructs breathing. Padded crib bumpers are banned under the Safe Sleep for Babies Act of 2021.

**Remedy:** Consumers should immediately stop using the recalled Grão de Gente crib bumpers and contact Zazaba International Inc. for instructions on how to properly dispose of the product and receive a full refund. Zazaba International Inc. is contacting all known consumers directly.



#### Forjas Pack and Play Mattresses

**Hazard:** The recalled mattress violates multiple provisions of the Safety Standard for Crib Mattresses, including the thickness test, and is missing the required warnings and labels. The product poses a suffocation hazard to infants.

**Remedy:** Consumers should immediately stop using the

recalled pack and play mattresses and discard them by cutting them in half, then send a photo of destroyed mattress to <u>customer.care@forias.com</u> to receive a full refund. Amazon and Forias Direct are contacting all known purchasers directly.

#### Coral Island Bubble Bear Crib Mattress

**Hazard:** The recalled crib mattresses violate the federal safety regulation for mattresses by failing to meet the flammability and labeling requirements, posing a fire hazard to children.

**Remedy:** Consumers should immediately stop using the recalled crib mattresses and contact the company by email to receive a full refund and for directions on how to dispose of the mattresses. Shenzhen Coral Island Furniture and Amazon are contacting all purchasers directly by email.



#### Spring Spirit and Biloban Pack and Play Mattresses

**Hazard:** The recalled mattresses violate multiple provisions of the federal safety regulation for crib mattresses, including the thickness test, and are missing warnings and labels. The product poses a suffocation hazard to infants.



**Remedy:** Consumers should immediately stop using and destroy the recalled mattresses and contact Biloban to receive a full refund and for directions on how to dispose of the mattresses. Biloban and Amazon are contacting all purchasers directly.

#### RH Baby & Child Jeune French Contemporary Upholstered Panel Cribs

**Hazard:** The recalled mattresses violate multiple provisions of the federal safety regulation for crib mattresses, including the thickness test, and are missing warnings and labels. The product poses a suffocation hazard to infants.



**Remedy:** Consumers should immediately stop using and destroy the recalled mattresses and contact Magik & Kover to receive a full refund and for directions on how to dispose of the mattress. Magik & Kover and Amazon are contacting all purchasers directly.

#### Moonsea Pack and Play Matresses

**Hazard:** The recalled mattresses violate multiple provisions of the federal safety regulation for crib mattresses, including the thickness test and missing warnings and labels. The product poses a suffocation hazard to infants.

**Remedy:** Consumers should immediately stop using the recalled pack and play mattresses and contact Moonseasleep to receive a full refund and for directions on how to dispose of the mattresses. Moonseasleep and Amazon are contacting all purchasers directly.



#### Beyond Baby Vibe Bear Playyard Mattresses

**Hazard:** The recalled mattresses violate multiple provisions of the federal safety regulation for crib mattresses, including the firmness and thickness tests and are missing warnings and labels. The product poses a suffocation hazard to infants.

**Remedy:** Consumers should immediately stop using the recalled mattresses and contact Vibe Bear by email to receive a full refund and for directions on how to dispose of the mattresses. Vibe Bear and Amazon are contacting all purchasers directly.

#### **DODO Baby House Pack and Play Mattresses**

**Hazard:** The recalled mattresses violate multiple provisions of the federal safety regulation for crib mattresses, including the thickness test and missing warnings and labels. The product poses a suffocation hazard to infants.

**Remedy:** Consumers should immediately stop using and destroy the pack and play mattresses by cutting them in half, then contact DODO Baby House to send photos of the destroyed products for a

full refund. DODO Baby House and Amazon are contacting all purchasers directly.

#### Shenzhen Two Pony Papablic Infant Swings

**Hazard:** The swings pose a suffocation risk because they were marketed, intended, or designed for infant sleep, and they have an incline angle greater than 10 degrees in violation of the federal safety regulations for Infant Sleep Products and the Safe Sleep for Babies Act. #### Jool Baby Nova Baby Infant Swings

**Hazard:** The swings pose a suffocation risk because they were marketed, intended, or designed for infant sleep, and they have an incline angle greater than 10 degrees in violation of the federal safety regulations for Infant Sleep Products and the Safe Sleep for Babies Act. In addition, the swing fails to meet mandatory warning requirements regarding sleep under the swing standard.

**Remedy:** Consumers should immediately stop using the recalled swings for sleep and contact Jool Baby to receive a free repair kit.



#### Dorel Juvenile Group Cosco Jump, Spin & Play Activity Center

**Hazard:** The activity centers' straps can detach or break while a child is in the activity center, posing fall and injury hazards to the child.



#### Zazaba International Grao de Gente Baby Nests

**Hazard:** The recalled baby nests violate the safety requirements of CPSC's Safety Standard for Infant Sleep Products, posing a suffocation risk and fall and entrapment hazards to infants. The failures include not having a stand and not meeting the requirements for side height, sleeping pad thickness, and fabric-sided openings. The product's sides are shorter than the minimum side height limit; the sleeping pad's thickness exceeds the maximum limit; and an infant could fall out of an enclosed opening at the foot of the lounger or become entrapped.



Additionally, the baby nest designs with head pillows violate the Safe Sleep for Babies Act of 2021's ban on inclined sleepers for infants because their sleep surfaces are inclined greater than ten degrees. Infant fatalities have occurred in inclined sleepers, after the infants rolled from their back to their stomach or side while unrestrained, or under other circumstances.

**Remedy:** Consumers should immediately stop using the recalled Grão de Gente baby nests and contact Zazaba International Inc. for instructions on how to properly dispose of the product and receive a full refund. Zazaba International Inc. is contacting all known consumers directly.

#### Mamibaby and Cosy Nation Baby Loungers

**Hazard:** The recalled baby loungers violate the federal safety regulations for Infant Sleep Products because the sides are too low to contain the infant; the sleeping pad is too thick, posing a suffocation hazard; an infant could fall out of an enclosed opening at the foot of the lounger or become entrapped; and the loungers do not have a stand, posing a fall hazard if used on elevated surfaces. These violations create an unsafe sleeping environment for infants.



Federal regulations require bicycles with seat heights that measure at or below 25 inches to be equipped with foot brakes and require a full coverage chain guard, intended to prevent entrapment of clothing or body parts.

# Polaris RZR 200 Youth Recreational Off-Road Vehicles

**Hazard:** The steering system can lock up while in use, posing a crash hazard and risk of serious injury to children.

**Remedy:** Consumers should immediately stop using the recalled vehicles and contact an authorized Polaris dealer to schedule a free repair to replace the steering rack assembly. Polaris has notified consumers to stop riding the vehicles and is contacting registered owners directly.

### Polaris Ranger XP Kinetic Recreational Off-Road Vehicles

**Hazard:** Pressing the brake and throttle pedals simultaneously can deactivate the throttle. If the brake is then released, the vehicle can move and the throttle can still be deactivated, posing a crash hazard and risk of serious injury.



**Remedy:** Consumers should immediately stop using the recalled vehicles and contact Polaris or an authorized Polaris

dealer to schedule a free repair, including an update to the vehicle control system. Polaris has notified consumers to stop riding the vehicles and is contacting registered owners directly.

# **CFMOTO ZFORCE 950 Recreational Off-Highway Vehicles**

**Hazard:** The shock absorber rod assembly can unthread and detach, causing suspension collapse, posing crash and tip-over hazards to the rider.

**Remedy:** Consumers should immediately stop using the recalled ROVs and contact an authorized CFMOTO dealer to schedule an appointment to bring the recalled vehicle into the dealer for a free repair. CFMOTO has issued a Stop Ride notice to consumers and is contacting all registered owners and dealers directly to provide more details about the repair.



#### Honda Motor Off-Road Motorcycles

**Hazard:** The grip can detach from the handlebar posing crash and injury hazards.

**Remedy:** Consumers should immediately stop using the recalled off-road motorcycles and contact American Honda Motor to schedule an appointment for a free inspection and repair. Honda is contacting all known purchasers directly.

#### **Baseus Magnetic Wireless Charging Power Banks**

**Hazard:** The lithium-ion battery in the power banks can overheat, posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled power bank models and contact Baseus for a full refund with proof of purchase, or a \$36 cash refund without proof of purchase. Baseus and Amazon are notifying all known purchasers directly.

#### IKEA VARMFRONT Power Banks

**Hazard:** The power banks can overheat posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled banks and return them to any IKEA store for a free replacement product or for a full refund. If you are unable to return it to a store, contact IKEA for instructions on how to dispose of the VARMFRONT Power Bank to receive a full refund. Proof of purchase (receipt) is not required to receive a full refund.



**Hazard:** The power bank's internal screws can come loose, causing a short circuit and overheating of the lithium-ion battery, posing a fire hazard. Do not put lithium-ion batteries in the trash or battery recycling boxes found at various retail and home improvement stores. They can cause fires and explosions if they are damaged or crushed and are a hazard when thrown in the trash.

**Remedy:** Consumers should immediately stop using the recalled Lenovo USB-C Laptop Power Banks and contact Lenovo for a free

replacement as well as instructions for properly disposing of lithium-ion batteries according to local and state regulations.

# myCharge POWER HUB All-In-One

**Hazard:** The recalled portable chargers can overheat while charging, posing fire and burn hazards.

**Remedy:** Consumers should immediately stop using the recalled portable chargers and contact myCharge for a free replacement portable charger.



### IKEA ASKSTORM 40W USB Chargers

**Hazard:** The USB charger's cable can become damaged or break over time, posing burn and electric shock hazards.

**Remedy:** Consumers should immediately stop using the recalled chargers and return the charger to any IKEA store for a full refund; or, if you are unable to return it to a store, contact IKEA for instructions on how to dispose of the ÅSKSTORM 40W USB Chargers to receive a full refund. Proof of purchase (receipt) is not required to receive a full refund.

# ALDI Ambiano Single Serve Coffee Makers

**Hazard:** The recalled coffee makers can expel hot water from the top of the machine, posing a burn hazard.

**Remedy:** Consumers should immediately stop using the recalled coffee makers. Consumers may return the unit to an ALDI store for a full cash refund of \$49.99, plus applicable sales tax. Alternatively, consumers may receive a \$75 ALDI electronic gift card when they visit www.recallrtr.com/aldicoffeemaker, register the recalled coffee maker, and receive instructions on how to cut the unplugged cord, dispose of the product, and upload photos of the coffee maker showing the model number, registration number, and cut cord.





#### BlendJet BlendJet2 Portable Blenders

**Hazard:** The recalled blenders can overheat or catch fire and the blender blades can break off, posing fire and laceration hazards to consumers.

**Remedy:** Consumers should immediately stop using the recalled blenders and contact BlendJet for a free replacement of the BlendJet 2 base unit. Consumers will need to remove and cut the rubber seal from the base of their recalled blender into three or more pieces and upload or email a photo showing the serial number on the bottom of the unit and its rubber seal in pieces to BlendJet at <u>www.blendjet.com/safetyandrecall</u> or <u>safety@blendjet.</u> <u>com</u> to receive a free replacement base. Consumers can identify whether they have a recalled unit by entering the serial number of their unit into the "Is my BlendJet 2 Recalled?" tool located at <u>www.blendjet.com/safetyandrecall</u>, or by calling BlendJet toll-free number at 844-334-0562.



#### Oreck Discover Upright Vacuums by TTI Floor Care

**Hazard:** The vacuum's electric cord plug prong can detach and remain in an electrical outlet when the vacuum is unplugged. This poses an electrical shock hazard to consumers.

**Remedy:** Consumers should immediately stop using the recalled vacuums and contact Oreck or their local Oreck dealer for instructions on how to obtain a free repair.



#### Brookstone TurboVac Handheld Rechargeable Vaccums

**Hazard:** The vacuums can short circuit during or after charging the battery, posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled vacuums and contact Southern Telecom to receive a full refund.



# **BISSELL Steam Shot Handheld Steam Cleaners**

Hazard: The recalled steam cleaners can expel hot water or steam onto users while heating or during use, posing a burn hazard.

Remedy: Consumers should immediately stop using the recalled steam cleaners, and contact BISSELL to receive either a \$60 credit to be used towards a **BISSELL.com** purchase, or a \$40 refund for each of the recalled steam cleaners.

#### Vornado Steamfast Home & Away Travel Steam Irons

Hazard: The power cord can become damaged near the cord bushing, which can lead to overheating of the cord, posing fire and burn hazards. In addition, cord damage near the bushing can result in exposed copper wires, posing a shock hazard.

# **Twin-Star International Infrared Quartz Electric Fireplaces**

Hazard: The electric fireplaces can overheat, posing a fire hazard.

**Remedy:** Consumers should immediately unplug the recalled electric fireplace and contact Twin-Star for a refund of the purchase price. Consumers should complete the online recall registration form at www.twinstarhome.com/recall or call Twin-Star for information on how to take part in this recall.







#### Best Buy Insignia Presure Cookers

**Hazard:** The pressure cooker has incorrect volume markings on the inner pot which can cause consumers to overfill the pot and hot food and liquids to be ejected when the pressure cooker is vented using the quick release method or opened while its contents are pressurized, posing a burn hazard to consumers.

**Remedy:** Consumers should immediately stop using the recalled pressure cookers and contact Best Buy for a free replacement of the inner pot and floating locking valve for signaling pressure.



#### Best Buy Insignia Air Fryers and Air Fyer Ovens

**Hazard:** The air fryers can overheat, causing the handles to melt or break, posing fire and burn hazards. Additionally, the air fryer ovens can overheat and the glass on the door can shatter, posing fire, burn and laceration hazards.

**Remedy:** Consumers should immediately stop using the recalled Insignia air fryers and air fryer ovens and visit <u>https://www.recallrtr.com/airfryer</u> for instructions



on how to submit photos of the recalled unit(s), the model number, purchase receipt, and on the destruction of the unit. Best Buy has contacted all known purchasers directly.

#### Secura Air Fryers

**Hazard:** A wire connection in the air fryer can overheat, posing fire and burn hazards.

**Remedy:** Consumers should immediately stop using the recalled air fryers and contact Secura for an Amazon gift card in the amount of \$45 or a free replacement. Secura is contacting all known purchasers.



#### **Empower Power XL Dual Basket Air Fryers**

**Hazard:** The plastic U-Channel connector used to optionally combine the two food baskets inside of the air fryers can break during use, posing a burn hazard.

**Remedy:** Consumers should immediately stop using the recalled dual basket air fryers and contact Empower Brands to receive a full refund.

#### Far Success Gevi Countertop Nugget Ice Makers

**Hazard:** The metal blades of the auger of the ice maker can break, resulting in small pieces of metal going into the ice basket, posing a laceration hazard.

**Remedy:** Consumers should immediately stop using the Countertop Nugget Ice Makers manufactured before June 1, 2022, and contact Far Success Trading Limited to receive a free replacement. Far Success Trading Limited is notifying all known purchasers directly.

#### Fortress Safe Biometric Gun Safes

**Hazard:** The biometric lock on the gun safes can be opened by unauthorized users, posing a serious injury hazard and risk of death.

**Remedy:** Consumers should immediately stop using the biometric reader in the recalled gun safes, remove the batteries, and contact Fortress to receive a free replacement safe.







### **Bulldog Biometric Gun Safes**

**Hazard:** The biometric lock on the gun safes can be opened by unauthorized users, posing a serious injury hazard and risk of death.

**Remedy:** Consumers should immediately stop using the biometric feature of the recalled safe, remove the batteries from the safe, and only use the key when storing firearms. Contact Bulldog to receive a repair kit or free replacement

safe for consumers with the Magnum Biometric Pistol Vaults, or a free replacement safe for consumers with the Magnum Biometric Top Load Pistol Vaults.

#### Machir Biometric Personal Safes

**Hazard:** The biometric lock on the safes can fail and be opened by unauthorized users, posing a serious injury hazard and risk of death.

**Remedy:** Consumers should immediately stop using the biometric lock feature, remove the batteries, and only use the key for the recalled safes to store their items until they get the free replacement. Contact Machir to receive instructions on disabling the biometric lock feature and on how to receive a free replacement safe.

#### Amazon BBRKIN Biometric Gun Safes

**Hazard:** The biometric lock on the gun safes can be opened by unauthorized users, posing a serious injury hazard and risk of death.

**Remedy:** Consumers should immediately stop using the biometric feature of the recalled safe, remove the batteries from the safe, and only use the key when storing firearms. Contact BBRKIN to receive a repair kit or to receive a free replacement safe.







### Awesafe Biometric Gun Safes

**Hazard:** The biometric lock on the safes can fail and be opened by unauthorized users, posing a serious injury hazard and risk of death.

**Remedy:** Consumers should immediately stop using the biometric feature, remove the batteries, and only use the key for the recalled safes to store firearms until they get the free replacement safe. Contact Awesafe to receive instructions on disabling the biometric feature and to receive a free replacement safe.

### Trader Joe's Mango Tangerine Scented Candles

**Hazard:** The candle flame can spread from the wick to the wax causing a larger than expected flame, posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled Mango Tangerine Scented Candles sold in June 2024 and return the candle to any Trader Joe's store for a full cash refund.

#### **Orly** Lavender Scented Candles

**Hazard:** The candle's flames can reach excessive heights and can ignite the bowl, posing fire and burn hazards.

**Remedy:** Consumers should immediately stop using the recalled lavender scented candle in a round wooden bread bowl, and return the product to any Cracker Barrel Old Country Store location for a full refund.







#### Focusee Tideway Hair Dryers

**Hazard:** The handheld hair dryers lack an immersion protection device, posing an electrocution or shock hazard to consumers, if they fall into water when plugged in. The CPSC has determined that hair dryers not equipped with the integral immersion protection present a substantial product hazard.

**Remedy:** Consumers should immediately unplug and stop using the recalled hair dryers and contact Tideway Shop to receive a free replacement.

#### StyleCraft Instinct Cordless Hair Clippers

**Hazard:** The lithium-ion battery in the recalled clippers can overheat, posing fire and burn hazards.

**Remedy:** Consumers should immediately stop using and charging the recalled clippers, and visit <u>www.stylecraftus.com/recall</u> for instructions to remove the battery and to receive a free battery replacement.



**Hazard:** The recalled Magnolia 3-wick candles were manufactured with the incorrect wax, which can cause excessive flames on the wicks and cause the glass candle containers to break, posing fire and laceration hazards.

**Remedy:** Consumers should immediately stop using the recalled candles and contact Magnolia for a full refund. Consumers who purchased the candles online will be contacted directly. Magnolia Market is directly contacting all known purchasers.







### MM JoyJolt Declan Glass Coffee Mugs

**Hazard:** The glass mugs can break and crack when filled with hot liquids, posing burn and laceration hazards.

**Remedy:** Consumers should immediately stop using the recalled coffee glasses and contact MM Products for a full refund.

#### Nestle USA Metallic Mugs sold with Starbucks Branded Gift Sets

**Hazard:** If microwaved or filled with extremely hot liquid, the mugs can overheat or break, posing burn and laceration hazards.

**Remedy:** Consumers should immediately stop using the recalled mugs, and either return them to the place of purchase or contact Nestlé USA for a full refund. Proof of purchase (receipt) is not required to receive a full refund.



**Hazard:** The chopper's blade can operate unexpectedly during assembly or when not enclosed in the container, posing a laceration hazard to consumers.

**Remedy:** Consumers should immediately stop using the recalled choppers and contact Walmart to receive a full refund. Consumers can bring the chopper to their nearest Walmart store for a refund.

#### Anker EverFrost Lithium-Ion Battery Powered Coolers

**Hazard:** The lithium-ion batteries in the Anker EverFrost Coolers can overheat, posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled coolers and contact Anker for a free replacement lithium-ion battery pack.









#### Char-Broil Digital Electric Smokers

**Hazard:** The smokers can leak electrical current during use, posing an electric shock hazard.

**Remedy:** Consumers should immediately stop using the recalled electric smokers and contact Char-Broil for a free repair kit. The repair kit consists of a Ground Fault Circuit Interrupter ("GFCI") plug (also known as a "pigtail"), a



clamshell enclosure to secure the GFCI pigtail, and a cable clamp. Instructions for installing each of these repair kit items will also be provided.

#### Traeger Grills Flatrock Flat Top Propane Grills

**Hazard:** The burner control knob can be incorrectly labeled, which can result in the grill being unintentionally left on, posing a fire hazard.

**Remedy:** Consumers should immediately stop using the recalled Traeger Flatrock Flat Top Grills and contact Traeger for inspection instructions and, if the burner control knobs are incorrectly labeled, consumers will receive a free repair kit.


