Lost wages are compensable within the timeframes established and up to the percentage and maximum benefit amount on the Schedule of Benefits, based on the victim/applicant's gross average weekly wage. You may forward this form to your employer to document your loss of earnings. Self employed individuals should instead submit their most recent federal income tax return with W2 or Schedule C attachments.
